A regular meeting of the Peru City Council was called to order by Mayor Ken Kolowski in the Peru City Council Chambers on Monday, June 5, 2023, at 7:00 p.m.

City Clerk Dave Bartley called the roll with Aldermen Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno present; Ballard Absent: Mayor Kolowski present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

PUBLIC COMMENT

PRESENTATION

Police Chief, Sara Raymond made the following presentation: On March 22,2023, Peru Police Officer Bradley Anderson heard the LaSalle Police Department being dispatched to Mickey's Massive Burrito for a male with a gunshot wound. Officer Anderson responded to the business to find an adult male on the ground, with a greying skin color, surrounded in blood. He was informed the male had been shot in the upper leg area. Officer Anderson, a trained and certified paramedic, began immediately rendering care. He was able to locate the entry wound, identify the wound to be an arterial bleed, and immediately applied direct pressure. He was later assisted by the LaSalle Ambulance service in applying the tourniquet he carries on his person, as well as continual direct pressure to the wound. The victim was ultimately transported to a medical facility. Without the efforts of Officer Anderson and his response to the business in LaSalle, it is without a doubt the victim would not be with us today. Officer Anderson's training, skill set, and his will for not only law enforcement, but also the fire service and paramedic service are commendable. He values all emergency services and takes regard to providing service for each in whatever situation is needed. It is my privilege to stand here today to be able to present this life saving award to Officer Bradley Anderson.

Phil Valle, on behalf of the Catholic War Veterans Post 1229, presented a check for \$1000 to Fire Chief, Jeff King. Mr. Valle thanks the fire department for their service and commitment.

Clerk Bartley called the roll with Alderman Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; Ballard absent; motion carried.

PUBLIC SERVICES COMMITTEE

Alderman Edgcomb made a motion to approve quote from J&M Displays in the amount of \$32,000 for July 3 celebration. O'Sadnick seconded the motion. Clerk Bartley called the roll with Aldermen Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; Ballard absent; motion carried. Mayor Kolowski announced this will be the last year for the fireworks celebration on Water Street. Mayor Kolowski explained the plan is to move the fireworks activities to Veteran's Park and make the event more family friendly.

Alderman Edgcomb made a motion to approve quote from Cunningham Recreation in the amount of \$116,100.20 for Sunset Park Playground renovation project Alderman Tieman seconded the motion. Clerk Bartley called the roll with Aldermen Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; Ballard absent; motion carried. Director of Recreation, Adam Thorson, reported this improvement to Sunset Park will be the first of many planned improvements across the park system. Adam Thorson announced the city received a grant for \$25,000 to offset the cost of these improvements and anticipate we will be able to secure this type of grant in coming years.

Alderman Lukosus made a motion the ordinance be adopted as written and read. Alderman Moreno seconded the motion. Clerk Bartley called the roll with Alderman Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; Ballard absent; motion carried.

Corporate Counsel Scott Schweickert presented a proposed ordinance entitled:

ORDINANCE NO. 6772

AN ORDINANCE AMENDING ORDINANCE NO. 6489 ENTITLED "AN ORDINANCE ESTABLISHING COMPENSATION FOR TEMPORARY PART-TIME EMPLOYEES OF THE PARKS, RECREATION, AND SPECIAL EVENTS DEPARTMENT"

Alderman Payton made a motion the ordinance be adopted as written and read. Alderman Tieman seconded the motion. Clerk Bartley called the roll with Alderman Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting ave; Ballard absent; motion carried.

RE: AN ORDINANCE AMENDING THE CITY OF PERU CODE OF ORDINANCES TO PROVIDE FOR THE REGULATION OF SHORT-TERM RENTALS

The proposed ordinance outlines numerous requirements for an operator to obtain a license to run a short-term rental or B&B, including a \$250 application fee, a \$50 deposit for a lawn sign for notice of a public hearing and at least \$500,000 of liability insurance through a provider or a hosting platform. Mayor Kolowski initiated a discussion regarding the proposed Short-Term Rentals ordinance stating the he in in favor of the changes in the ordinance to protect the City of Peru and most importantly the residents of Peru. Mayor commented that he prefers the plan to request permission and have a public hearing. Alderman Sapienza asked if we could select only permissible locations or zoning and eliminate the rest of the city. Alderman Jim Lukosus asked whether a regulation identifying an area where short-term rentals and bed and breakfasts were prohibited would be considered discriminatory. Schweickert said it could be susceptible to a challenge. Alderman Moreno commented on his previous experience serving on the planning and zoning board, noting, having a lawn sign in front of a potential rental property stuck out to him as a short-term rental owner could approach the city with a letter of support from the community. Alderman Moreno stated as a council, I don't think we are going to sit up here in favor or against that if

someone in that community doesn't want them in their neighborhood. Corporate Counsel Scott Schweickert explained that after an operator submits an application to the city, they will be referred to the city's Planning and Zoning Commission and a date for a public hearing will be set, according to the draft ordinance. Once the public hearing is scheduled, the city will mail a notice to the properties within 200 feet of the subject property. If the application is approved, the operator will be required to pay a \$150 inspection fee every year prior to license renewal. Alderman Sapienza said the council may want to consider stretching the notice to 300 feet because of the potential noise. Mayor Kolowski said the most important consideration to him is to protect the citizens and the city. Alderman Sapienza stated he is in agreement with the mayor with regard to protecting the citizens. Alderman Sapienza suggested we look at 300 feet and give those people a real definite say and think about the percentage of people to say yes. Alderman Sapienza also noted his concerns with noise given there are permissible limits after hours. Alderman Edgcomb stated the people who have reached out to him would like the see council try to push the rentals into business districts in the area.

DEFINITIONS

ACTUAL CASH VALUE VALUATION

This valuation method pays for the cost to repair or replace damaged property with like kind and quality, less reasonable deductions for wear and tear, deterioration and economic obsolescence.

ACTUAL LOSS SUSTAINED

This coverage insures against loss of business income and resulting extra expenses that arises from a suspension of your business from a covered loss up to the number of months specified in the form. There is no specific dollar limit and no coinsurance clause applied to claims covered under this type of coverage.

ADVERTISING LIABILITY

This coverage insures you against claims of libel and slander; publication of information that disparages another's goods, products, or services; the publication of material that violates a person's right of privacy; the use of another's advertising idea in your advertisement; and infringement of another's copyright, trade dress, or slogan in your advertisement. This would include material placed on the Internet or on similar electronic means of communications.

AGREED VALUE VALUATION

This coverage removes the coinsurance requirement from your property policy. With it your company agrees that the limits of insurance purchased by you are adequate, and any coinsurance requirements will be waived in the event of a covered loss.

AUTOMOBILE LIABILITY

This coverage protects against claims alleged for bodily injury and property damage arising from the ownership, maintenance or use of any covered auto.

BUILDERS RISK/INSTALLATION FLOATER

Insureds engaged in construction of structures are exposed to special problems involving constantly changing values, special hazards associated with construction activities and the variety of interests involved in such projects. Pursuant to legal notice published in the News Tribune in the manner provided by law, the Planning/Zoning Commission of the City of Peru convened for a public hearing on Wednesday, June 7, 2023, at 5:00 p.m. in the City Municipal Building, 1901 Fourth Street, Peru, IL, to consider the Petition of David G. Mudge ("Petitioner") concerning property commonly known as 1909 West Street in the City of Peru, Illinois, legally described as follows:

Parcel I:

The North Sixty (60) feet of the South One Hundred Fifteen (115) feet of the following tract of land: Commencing at the Northwest corner of Section Sixteen (16), in Township Thirty-three (33) North Range One (1) East of the Third Principal Meridian, running thence South along the Section line Four Hundred Forty-two and Four Tenths feet (442.4), running thence East Parallel with the North Section line Two Hundred Eight and Seven Tenths feet (208.7), running thence North parallel with the West Section line Four Hundred Forty-two and Four Tenths feet (442.4), running thence West along the North Section line Two Hundred Eight and Seven Tenths feet (208.7) to the place of beginning, excepting and reserving herefrom any and all coal, mineral and mining rights which may have been heretofore conveyed or severed from said premises; and

Parcel II:

The South Thirty feet (30) of the North Sixty feet (60) of the South One Hundred Seventy-five (175) feet of the following tract of land: Commencing at the Northwest corner of Section Sixteen (16), in Township Thirty-three(33) North, Range One, East of the Third Principal Meridian, running thence South along the Section line Four Hundred Forty-two and Four Tenths (442.4) feet, running thence East parallel with the North Section line Two Hundred Eight and Seven Tenths (208.7) feet, running thence North parallel with the West Section line four Hundred

Forty-two and Four Tenths (442.4) feet, running thence West parallel with the North Section line Two Hundred Eight and Seven Tenths (208.7) feet to the place of beginning; excepting and reserving herefrom any and all coal, mineral and mining rights which may have heretofore been conveyed from said premises;

all being situated in the City of Peru, County of LaSalle, and State of Illinois.

PIN #: 17-16-100-028 ("Property")

Petitioner desires to construct a new 30' x 50' detached garage on the Property and requests the following relief under the City's Zoning Ordinance, to wit:

- (1) A variance to increase the maximum area of all garages and accessory structures from the lesser of 1,200 sq. ft. or the ground floor living area of the primary residence, as provided in Section 6.01.1(e), to not more than 1,500 sq. ft.;
- (2) A variance to increase the maximum area for all detached garages from the lesser of 990 sq. ft. or the ground floor living area of the principal residence, as provided in Section 6.01.3(c), to not more than 1,500 sq. ft.;
- (3) A variance to reduce the minimum side yard for an interior lot from not less than 7', as provided Section 10.03(h)(2), to not less than 5'; and
- (4) For such other and further relief as may be reasonable and appropriate.

The Property is zoned R-2 Single-Family, Detached Dwelling District.

Planning/Zoning Commission Members Miller, Lucas, Kalsto, Brady, Jones, and Becker were present at the hearing. Member Grabowski was absent.

Petitioner David G. Mudge appeared and was duly sworn. Mr. Mudge testified that his garage burned down a few months ago and he was looking to build a new one. The Property is situated on a larger than normal lot that is 90' x 200'. The garage will be constructed at least 28' away from any building on the neighbor's property to the north, and about 6' from the north Property line. The garage will be constructed 10' away from the Petitioner's house. It will be 48' away from the neighbor to the east.

Petitioner testified further that he takes pride in the appearance of his Property and the garage will not be some ramshackle building. He wants the garage to blend in and look like it had been there.

In response to questioning from Chairman Miller, Petitioner stated the proposed patio is new and does not currently exist. The reason why the Petitioner is asking for the setback variance is because there is a large, mature sycamore tree in between the house and the proposed garage. The petitioner reiterated that it is a large lot and the garage won't be cumbersome to any of the neighbors.

City Director of Engineering and Zoning, Eric Carls, said his office has reviewed the Petition and has no concerns. Due to the size of the lot, there is plenty of room to support a building of this size and it should have no negative impacts on the neighborhood.

In response to questioning from Member Lucas, Mr. Mudge stated that he had spoken with his neighbors to the south, east, and north of the Property, and none of them had any issues with the proposed improvements.

There were no public comments or objections.

The Planning/Zoning Commission found the requested relief will not alter the essential character of the locality; will not be detrimental or injurious to other properties in the area; will not impair an adequate supply of light or air to adjacent properties, or increase the danger of fire, or endanger the public safety, or diminish or impair property values and will not increase street congestion and, therefore, favorable recommended to the City Council that it grant the relief as prayed for in the Petition.

Member Lucas moved, and Member Jones seconded, to favorably recommend the City Council approve the Petition as prayed for. The motion passed unanimously: 6 aye, 0 nay, and 1 Member absent.

AN ORDINANCE GRANTING VARIANCES AS SOUGHT BY THE PETITION OF DAVID G. MUDGE CONCERNING PROPERTY LOCATED AT 1909 WEST STREET IN THE CITY OF PERU, ILLINOIS

WHEREAS, after legal ad notice duly published in the News Tribune in the manner provided by law, the Planning/Zoning Commission of the City of Peru conducted a public hearing on June 7, 2023, to consider the Petition of David G. Mudge ("Petitioner") concerning property located at 1909 West Street in the City of Peru, Illinois, legally described as follows:

Parcel I:

The North Sixty (60) feet of the South One Hundred Fifteen (115) feet of the following tract of land: Commencing at the Northwest corner of Section Sixteen (16), in Township Thirty-three (33) North Range One (1) East of the Third Principal Meridian, running thence South along the Section line Four Hundred Forty-two and Four Tenths feet (442.4), running thence East Parallel with the North Section line Two Hundred Eight and Seven Tenths feet (208.7), running thence North parallel with the West Section line Four Hundred Forty-two and Four Tenths feet (442.4), running thence West along the North Section line Two Hundred Eight and Seven Tenths feet (208.7) to the place of beginning, excepting and reserving herefrom any and all coal, mineral and mining rights which may have been heretofore conveyed or severed from said premises; and

Parcel II:

The South Thirty feet (30) of the North Sixty feet (60) of the South One Hundred Seventy-five (175) feet of the following tract of land: Commencing at the Northwest corner of Section Sixteen (16), in Township Thirty-three(33) North, Range One, East of the Third Principal Meridian, running thence South along the Section line Four Hundred Forty-two and Four Tenths (442.4) feet, running thence East parallel with the North Section line Two Hundred Eight and Seven Tenths (208.7) feet, running thence North parallel with the West Section line four Hundred Forty-two and Four Tenths (442.4) feet, running thence West parallel with the North Section line Two Hundred Eight and Seven Tenths (208.7) feet to the place of beginning; excepting and reserving herefrom any and all coal, mineral and mining rights which may have heretofore been conveyed from said premises;

all being situated in the City of Peru, County of LaSalle, and State of Illinois. PIN #: 17-16-100-028 ("Subject Property"); and

WHEREAS, the Subject Property is zoned R-2 Single-Family, Detached Dwelling District; and

WHEREAS, Petitioner desires to construct a new 30' x 50' detached garage on the Subject Property and requests the following relief under the City's Zoning Ordinance, to wit:

- (1) A variance to increase the maximum area of all garages and accessory structures from the lesser of 1,200 sq. ft. or the ground floor living area of the primary residence, as provided in Section 6.01.1(e), to not more than 1,500 sq. ft.;
- (2) A variance to increase the maximum area for all detached garages from the lesser of 990 sq. ft. or the ground floor living area of the principal residence, as provided in Section 6.01.3(c), to not more than 1,500 sq. ft.; and
- (3) A variance to reduce the minimum side yard for an interior lot from not less than 7', as provided Section 10.03(h)(2), to not less than 5'; and

WHEREAS, the Planning/Zoning Commission has made its report of the hearing and has unanimously recommended that the City Council approve the relief as sought by the Petitioner.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: The City Council finds as facts the recitals hereinbefore set forth.

SECTION 2: The Subject Property is hereby granted: (1) a variance to increase the maximum area of all garages and accessory structures from the lesser of 1,200 sq. ft. or the ground floor living area of the primary residence, as provided in Section 6.01.1(e), to not more than 1,500 sq. ft.; (2) A variance to increase the maximum area for all detached garages from the lesser of 990 sq. ft. or the ground floor living area of the principal residence, as provided in Section 6.01.3(c), to not more than 1,500 sq. ft.; and (3) A variance to reduce the minimum side yard for an interior lot from not less than 7', as provided Section 10.03(h)(2), to not less than 5'; all for the purpose of constructing a 1,500 sq. ft. detached garage on the Subject Property in accordance with plans on file with the City.

Nothing in this Ordinance shall be construed to preempt any private covenants and restrictions that may be applicable to the Subject Property.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval according to law.

AN ORDINANCE AMENDING THE CITY OF PERU CODE OF ORDINANCES TO PROVIDE FOR THE LICENSING AND REGULATION OF BED AND BREAKFAST ESTABLISHMENTS AND SHORT-TERM RENTALS

WHEREAS, the City of Peru, an Illinois home rule municipal corporation ("City"), has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and promote the public health, safety and welfare of its citizens; and

WHEREAS, the City believes that bed and breakfast establishments and short-term rentals pose life-safety, quality of neighborhood, security, fire safety, tax revenue, and other concerns that can have cause a negative impact on surrounding properties and the City as a whole; and

WHEREAS, the City desires to promote the public health, safety, and welfare by licensing and regulating the operation of bed and breakfast establishments and short-term rentals within the City of Peru; and

WHEREAS, the City Council finds and determines, after full investigation and consideration, that it is necessary and appropriate to amend Chapter 26 – BUSINESSES of the City's Code of Ordinances to provide for the creation of a new "ARTICLE X. – BED AND BREAKFASTS AND OTHER SHORT-TERM RENTALS."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: Recitals. The City Council finds as fact the recitals contained in the preamble to this Ordinance and incorporates them herein by reference.

<u>SECTION 2:</u> <u>Code Amendment.</u> Chapter 26 – BUSINESSES of the City's Code of Ordinances shall be and is hereby amended to provide for the creation of "ARTICLE X. – BED AND BREAKFASTS AND OTHER SHORT-TERM RENTALS," which shall read as follows:

Chapter 26 – BUSINESSES

ARTICLE X. – BED AND BREAKFASTS AND OTHER SHORT-TERM RENTALS

Sec. 26-260. – Purpose.

The purpose of this Article is to promote the public health, safety, and welfare by licensing the operation of Bed and Breakfast Establishments and other Short-Term Rentals within the City of Peru.

Sec. 26-261. – Definitions.

For purposes of this Article, the following words and phrases shall have the following meanings, and are hereby defined as follows:

Bed and Breakfast Establishment: An Operator-occupied residence providing accommodations for a charge to the public with no more than 5 Guest rooms for rent, in operation for more than 10 nights in a 12-month period. Breakfast may be provided to the Guests only. Bed and Breakfast Establishments shall not include motels, hotels, boarding houses, food service establishments, or Short-Term Rentals. For purposes of this paragraph, "Operator" shall mean the owner of the Bed and Breakfast Establishment, or the owner's agent, who is required to reside in the Bed and Breakfast Establishment, or on contiguous property.

Bedroom: A room intended for sleeping or placement of a bed.

Dwelling or Dwelling Unit: A building, or portion thereof, or an accessory structure located on the same premises as of a single-family home, which is designed or used exclusively for residential occupancy and forms a single habitable unit with facilities which are used or intended to be used for living, sleeping, cooking, bathing and eating.

Guest: A person who rents or occupies a Bed and Breakfast Establishment or Short-Term Rental. The singular shall include the plural.

Host: An Owner and/or Operator of a Bed and Breakfast Establishment or Short-Term Rental that provides accommodations to Guests through use of a Hosting Platform.

Hosting Platform: A marketplace entity, in whatever form or format which facilitates Short-Term Rentals through advertising, matchmaking or other means, using any medium or facilitation, or from which the operator of the hosting platform derives revenue, including booking fees or advertising revenues from providing or maintaining the marketplace information.

Multi-Unit Building: A building that is designed and built with two (2) or more Dwellings.

Operator: Any person who has charge, care, control or management of a rental unit or building, in which rental units are let, including but not limited to building managers, managing agents, brokers or superintendents.

Owner: Any person who alone, jointly or severally with others has legal title to any Dwelling Unit or Multi-Unit Building, with or without accompanying actual possession thereof; or is an executor, administrator, trustee or guardian of the estate of the Owner; is a mortgagee in possession, or is a senior officer or a trustee of the association of unit Owners of a homeowners' association. Owner shall also mean any homeowners' association or other legal entity having the charge, care or control of any common area which serves in whole or in part one or more Multi-Unit Buildings.

Short-Term Rental: A Dwelling Unit that is offered for rent to Guests for a period of less than 30 consecutive days at a time. The term "Short-Term Rental" shall not include Hotels, Motels, Bed and Breakfast Establishments, Dwelling Units owned by the federal government, the state, or any of their agencies or political subdivisions; or facilities licensed by the state as health care facilities.

Sec. 26-262. – Zoning and Other City Requirements.

Bed and Breakfast Establishments and other Short-Term Rentals shall be subject to the City's Zoning Ordinances and all other City ordinances, codes, regulations, and requirements; and shall only be available in zoning districts where such use is explicitly permitted by special use.

Sec. 26-263. – License Required; Application.

- (a) License Required. It shall be unlawful for any person to conduct, keep, manage or operate or cause to be conducted, kept, managed or operated any Dwelling Unit as a Bed and Breakfast Establishment or Short-Term Rental without a valid license issued by the City. A license shall be obtained for each Bed and Breakfast Establishment or Short-Term Rental and shall not be transferable. All such licenses are required to be renewed annually, subject to the same condition as the original license. Such license shall be issued by the City in accordance with this Article.
- (b) *Multi-Unit Buildings*. The City will not approve a license for a Bed and Breakfast Establishment or Short-Term Rental in a Multi-Unit Building having a condominium or home owners' association unless it is first approved by the association. No more than one quarter of the units in a Multi-Unit Building having 4 or more units shall be converted to Short-Term Rentals. A separate license shall be required for each Dwelling Unit in a building utilized as a Bed and Breakfast Establishment or Short-Term Rental.
- (c) License Application. To license a Dwelling Unit as a Bed and Breakfast Establishment or Short-Term Rentals, the Owner shall submit a written application on a form provided by the City that will contain the following information and other additional information as may be determined necessary by the City:
 - (1) The name, address, telephone number, and email of the Owner of the Dwelling Unit.
 - (2) Whether the Dwelling Unit is sought to be rented as a Bed and Breakfast Establishment or Short-Term Rental, and whether it will be owner-occupied or non-owner occupied.
 - (3) The street address and zoning district where the Dwelling Unit is located, along with other identification if there is more than one Dwelling Unit in the building or it shares the same street address.
 - (4) A floor plan showing all bedrooms and bathrooms in the Dwelling Unit, including the square footage of each bedroom.
 - (5) A site plan showing all buildings and parking on the premises, identifying the number of off-street parking spaces provided for the Dwelling Unit.
 - (6) The maximum number of occupants to which the Operator intends to rent the Dwelling Unit in any given rental period.
 - (7) The length of the typical rental period for which the applicant intends to rent the Dwelling Unit.
 - (8) Whether the Owner will be the Operator of the Bed and Breakfast or Short-Term Rental. If not, the name, address, telephone number, and email of the Operator.
 - (9) A statement certifying that each bedroom has a working smoke alarm, that there is a working carbon monoxide detector on each floor, and that the Owner or agent will check those devices at least every 90 days.
 - (10) Proof of liability insurance as required by this Article.

- (11) A statement certifying that the Owner consents to inspections by the City and will make the Dwelling Unit available for inspection upon request.
- (12) Such other information as the City deems appropriate.
- (d) *Initial License Application Fee.* An initial application for a license to operate a Dwelling as a Bed and Breakfast Establishment or Short-Term Rental shall be accompanied by a non-refundable application fee of \$250 to cover City's costs of review, certified mailings, and publication of the public hearing. The application shall also be accompanied by a refundable \$50 deposit for a yard sign providing notice of such public hearing.
- (e) *Public Hearing*. Upon submission of a complete initial application to operate a Dwelling as a Bed and Breakfast Establishment or Short-Term Rental, it shall be referred to the City's Planning/Zoning Commission, and a public hearing shall be scheduled for the Planning/Zoning Commission's review and recommendation of a special use for such purpose.
- (f) *Notice of Public Hearing*. Once the public hearing before the Planning/Zoning Commission is scheduled, the City shall mail notice thereof to all owners whose addresses appear on the current tax assessment list, of real property located within a radius of two hundred feet (200') of the subject property, inclusive of public streets, alleys and other public ways. The notice shall contain the applicant's name, the address of the subject property, the matter under consideration, and the date, time, and location of the relevant meeting of the Planning/Zoning Commission.
- (g) City Council Approval. Following the review and recommendation of the Planning/Zoning Commission, the City Council shall approve or deny the special use and license for the Bed and Breakfast Establishment or Short-Term Rental subject to the requirements of this Article.
- (h) *Inspection; Fee.* Prior to issuance of a license to operate a Bed and Breakfast Establishment or Short-Term Rental, the Owner shall agree to an inspection of the Dwelling by the City and once a year prior to license renewal. The Owner shall pay a fee to the City of \$150 prior to each such inspection.

Sec. 26-264. – License Renewal.

- (a) Renewal License Application. Every renewal application shall satisfy all requirements set forth in this Article.
- (b) *License Renewal Fee*. A license renewal application shall be accompanied by a \$25 license renewal fee.
- (c) Administrative License Renewal. If a license was issued for the prior year, approval of a renewal license shall be obtained from the Mayor or his/her designee, provided the previously-issued license was not revoked or suspended, and the Bed and Breakfast Establishment or Short-Term Rental did not receive citation(s) from any City department during said prior calendar year.

Sec. 26-265. – **Hosting Platform**. All Bed and Breakfast Establishments and Short-Term Rentals must be operated through a Hosting Platform.

Sec. 26-266. – Collection and Remittance of Taxes.

- (a) *Duty imposed*. It shall be the duty of every Owner or Operator of a Bed and Breakfast Establishment or Short-Term Rental licensed under this Article to collect and remit taxes to the City in accordance with this Section and the provisions of Chapter 102 TAXATION, ARTICLE II. HOTEL OR MOTEL ROOM RENTAL TAX, of the City's Code of Ordinances.
- (b) Payment of Taxes. The Owner or Operator of each Bed and Breakfast Establishment or Short-Term Rental shall file tax returns with the City, on forms prescribed by the City's Director of Finance, showing the gross rental receipts received during each calendar month period. The return shall be due on or before the 30th day of the calendar month succeeding the end of the month filing period and shall be accompanied by a Host transaction history report for that month from each Hosting Platform utilized by the Owner or Operator. At the time of filing such tax returns, the Owner or Operator shall pay to the City's Director of Finance all taxes due for the period to which the tax return applies. The Owner or Operator shall be exempt from filing a tax return with City if the Owner or Operator exclusively uses a Hosting Platform which has an agreement with the City that provides for the collection and remittance of taxes by said Hosting Platform.

Sec. 26-267. – Requirements and Standards.

- (a) All Bed and Breakfast Establishments and Short-Term Rentals shall meet the following standards:
 - (1) Bed and Breakfast Establishments and Short-Term Rentals shall meet the State Fire Marshal's requirements for one and two-family dwellings and other applicable City codes.
 - (2) Manual extinguishing equipment shall be provided on each floor in accordance with NFPA 10 Standards for the Installation of Portable Fire Extinguishers.
 - (3) All combustibles or flammable liquids shall be stored in approved metal containers and shall not be stored in or under stairways.
 - (4) No cooking facilities shall be permitted in guest rooms.
 - (5) All hallways and stairways shall be adequately lighted.
 - (6) No portable heating devices shall be permitted in Guest rooms.
 - (7) Smoke detectors shall be provided in each guest room.
 - (8) Bed and Breakfast Establishments shall also comply with all requirements set forth by the Bed and Breakfast Act, 50 ILCS 820/1 *et seq*.
- (b) No Owner or Operator of a Bed and Breakfast Establishment or Short-Term Rental shall:
 - (1) Rent or lease any Dwelling Unit for any period of time shorter than forty-eight (48) consecutive hours.
 - (2) Rent or lease any Dwelling Unit more than once within any consecutive twenty-four-hour period measured from the commencement of one rental to the commencement of the next.
 - (3) Advertise an hourly rate or any other rental rate for a Dwelling Unit based on a rental period of fewer than twenty-four (24) consecutive hours.

- (4) Serve or otherwise provide any food or beverage to any Guest, except if licensed as a Bed and Breakfast Establishment in accordance with this Article.
- (5) Cause or permit, by action or failure to act, the Dwelling or its use to suffer from and/or create any violation of the City's building codes, ordinances or regulations.
- (6) Allow fireworks to be used on the premises of a Dwelling Unit.
- (c) Every Owner and Operator of a Bed and Breakfast Establishment or Short-Term Rental shall:
 - (1) Be subject to inspection by staff members of the City's Engineering and Zoning Department, Fire Department, or their respective designees.
 - (2) Keep a register in which the name of every Guest and his/her arrival and departure dates are recorded. The Owner or Operator shall make said guest register freely accessible to any officer of the City's Engineer and Zoning, Police, and/or Fire Departments.
 - (3) Post in a conspicuous place within the Bed and Breakfast Establishment or Short-Term Rental, the name and telephone number of the Owner and Operator identified in the application and the address and unit number of the Dwelling Unit.
 - (4) Post on the front entrance or in the front window of the Bed and Breakfast Establishment or Short-Term Rental, a current license issued by the City stating the Owner and Operator's name, a 24-hour telephone number to reach the Owner and/or Operator, and the maximum occupancy of the Dwelling Unit.
 - (5) Clean the Dwelling Unit and discard all food and beverages between Guests. The kitchen, including all dishes, utensils, pots, pans, and other cooking utensils, shall be cleaned and sanitized between Guests.
 - (6) Provide Guests with individual soap and clean individual bath cloths and towels. Clean bed linen in good repair shall be provided for each Guest who is provided accommodations and shall be changed as necessary, but not less than once each week and between Guests.
 - (7) Shall provide Guests with materials prepared by the City that include: (i) a summary of the City's parking requirements, noise ordinance and other applicable offenses against the public peace; (ii) a reminder that the rental property is located in a residential or mixed-use neighborhood and that neighbors may not be vacationing, (iii) the applicable trash pickup date, (iv) and a statement informing the Guests that neighboring property owners may contact the Owner, Operator, and/or Peru Police to report any issues relating to the property.

Sec. 26-268. – **Insurance Required.** An Owner and/or Operator must obtain liability insurance either through a provider or, if applicable, through the Hosting Platform, of at least \$500,000.00. This insurance policy need not cover intentional acts.

Sec. 26-269. – **Maximum Occupancy.** No Owner or Operator shall permit the maximum occupancy of any Dwelling Unit utilized as a Bed and Breakfast Establishment or Short-Term Rental to be exceeded. The maximum occupancy of any Dwelling Unit shall be as follows:

Number of Bedrooms	Maximum Number of Persons
Studio/1-bedroom	2
2-bedroom	4
3-bedroom	6
4-bedroom	8
5-bedroom	10
6-bedroom	12

Sec. 26-270. – Violation; Penalty

- (a) Any Owner, tenant or other person who shall be found to have violated any of the provisions of this Article shall be guilty of an offense punishable as follows:
 - (1) The fine for a first violation is two hundred fifty dollars (\$250.00).
 - (2) The fine for a second violation is five hundred dollars (\$500.00).
 - (3) The fine for a third or subsequent violation is seven hundred fifty dollars (\$750.00).
- (b) Each day a provision of this Article is found to have been violated constitutes a separate violation subject to the fine schedule set forth in this Section.
- (c) Any fines shall be debts due and owing to the City that the City may collect by any means allowed by law, including, but not limited to, filing a lien against the premises containing the Dwelling Unit.
- (d) The fines provided for herein shall not be construed as limiting the power of a court of competent jurisdiction or an administrative hearing officer to impose other penalties and/or remedies as provided for by applicable legislation. In addition, a licensee found to have violated any provision of this Article may be subject to license and Certificate of Occupancy revocation, suspension, or nonrenewal.

Sec. 26-271. – Revocation and Suspension Procedures

- (a) The Mayor may revoke or suspend a license issued pursuant to this Article for any of the following reasons:
 - (1) If the Owner or Operator violates any of the provisions of this Article;
 - (2) If the Owner or Operator is deemed to have maintained a nuisance upon the premises in violation of City ordinances;
 - (3) If the Owner or Operator is deemed to have allowed criminal activity to occur upon the premises; and/or
 - (4) If the City or other governmental agency condemns the Bed and Breakfast Establishment, Short-Term Rental, or the premises wherein it is located.
- (b) Not less than fourteen (14) business days prior to a revocation hearing for a license issued pursuant to the terms of this Article, the Community Service Officer shall send, via First Class U.S. mail, a notice of revocation hearing to the Owner and Operator, or his/her respective authorized agents at the address provided on the most recent license application. Notice shall be sufficient if sent to the address of the authorized agent indicated on the license application. Said notice shall include the following:

- (1) Description of the Bed and Breakfast Establishment or Short-Term Rental, sufficient for identification:
- (2) A statement that the license is subject to revocation;
- (3) A statement of the reasons for the revocation;
- (4) The date and time upon which a revocation hearing shall occur; and
- (5) The location for said revocation hearing.
- (c) If the Community Service Officer certifies to the Mayor that he/she has reason to believe that immediate suspension of the license is necessary to prevent the threat of immediate harm to the community, the Mayor may, upon the issuance of a written order stating the reason for such conclusion and without notice or hearing, order the license suspended for not more than fourteen (14) days. The Mayor may extend the suspension during the pendency of a hearing upon a written determination that doing so is necessary to prevent the aforesaid harm to the community.
- (d) Hearings shall be conducted by the Mayor in accordance with procedures drafted by the Corporation Counsel.
- (e) Within ten (10) business days after the close of the hearing, the Mayor shall issue a written decision that shall constitute a final determination for purposes of judicial review pursuant to the Illinois Administrative Review Law, 735 ILCS 5/3-101 *et seq.*, as amended. In reaching a decision, the Mayor may consider any of the following:
 - (1) The nature of the violation;
 - (2) The nature and extent of the harm caused by the licensee's action or failure to act;
 - (3) The factual situation and circumstances surrounding the violation;
 - (4) Whether or not the action or failure to act was willful; and
 - (5) The record of the licensee with respect to violations.
- (f) A licensee whose license has been revoked shall not be eligible to reapply for a new license.

SECTION 3: This Ordinance shall be in full force and effect immediately from and after its passage, approval and publication according to law.

AN ORDINANCE APPROVING A TEXT AMENDMENT TO THE CITY OF PERU ZONING ORDINANCE RELATING TO SPECIAL USES FOR BED AND BREAKFAST ESTABLISHMENTS AND SHORT-TERM RENTALS IN CERTAIN ZONING DISTRICTS

WHEREAS, a Petition was filed by Francisco Sandoval d/b/a Pita Rey Estates LLC seeking a special use pursuant to Section 10.04(c)(2) of the City of Peru's Zoning Ordinance to operate a "Bed and Breakfast Facility" at certain property located at 4 Center Place in the City of Peru; and

WHEREAS, the City Planning/Zoning Commission conducted a public hearing to consider the Petition on April 19, 2023; and

WHEREAS, while the Planning/Zoning Commission unanimously recommended that the City Council grant the special use, it was recognized by the Planning/Zoning Commission and City Council that: (1) the relief sought was, in fact, to offer the property as a short-term rental through AirBnB and similar websites; and (2) the Zoning Ordinance's definition of "bed and breakfast establishment" as "an operator-occupied residence providing to the public overnight guest room accommodations and breakfast for a charge" did not adequately describe the proposed use, and (3) the City did not have sufficient regulations in place for short-term rentals to protect the public health, safety and welfare of the City; and the City Council deferred taking action on the special use until such regulations were thoroughly reviewed and established with input from the community; and

WHEREAS, a similar Petition was subsequently filed by Timothy Bott seeking a text amendment to Section 11.05(d) of the Zoning Ordinance to add "bed and breakfast establishment" or other defined use for short-term rentals as a special use available in B-4 Highway Business Districts, and for approval of such special use to offer a dwelling unit at 2724 4th Street in the City of Peru as a short-term rental through AirBnB or similar websites; and

WHEREAS, the Planning/Zoning Commission conducted a public hearing to consider the Petition of Timothy Bott on May 3, 2023, and said hearing was continued without a recommendation pending the City Council's decision on allowing and regulating short-term rentals; and

WHEREAS, after two months of careful consideration and public discourse, the Corporate Authorities of the City of Peru duly passed and adopted Ordinance No. _____ entitled: "An Ordinance Amending the City of Peru Code of Ordinances to Provide for the Licensing and Regulation of Bed and Breakfast Establishments and Short-Term Rentals" on the same date hereof, which ordinance licenses and regulates bed and breakfast establishments and short-term rentals in certain zoning districts where permitted by special use; and

WHEREAS, the City Council of the City of Peru finds and determines that a text amendment to the Zoning Ordinance is necessary to clarify the definition for bed and breakfast establishments and short-term rentals and to establish the zoning districts where they may be permitted by special use.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: The City Council finds as facts the recitals hereinbefore set forth and hereby incorporates them by reference as if fully restated herein.

<u>SECTION 2:</u> ARTICLE III – RULES AND DEFINITIONS, Section 3.02. Specific Definitions, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language and deleting the stricken language, as follows:

3.02. Specific definitions.

. . .

Bed and breakfast establishment. An operator occupied residence providing to the public overnight guest room accommodations and breakfast for a charge. Bed and breakfast establishments shall not be hotels or motels.

Bed and Breakfast Establishment. An Operator-occupied residence providing accommodations for a charge to the public with no more than 5 Guest rooms for rent, in operation for more than 10 nights in a 12-month period. Breakfast may be provided to the Guests only. Bed and Breakfast Establishments shall not include motels, hotels, boarding houses, food service establishments, or Short-Term Rentals. For purposes of this paragraph, "Operator" shall mean the owner of the Bed and Breakfast Establishment, or the owner's agent, who is required to reside in the Bed and Breakfast Establishment, or on contiguous property.

. . .

Short-Term Rental. A dwelling that is offered for rent to guests for a period of less than 30 consecutive days at a time. The term "Short-Term Rental" shall not include Hotels, Motels, Bed and Breakfast Establishments, dwelling units owned by the federal government, the state, or any of their agencies or political subdivisions; or facilities licensed by the state as health care facilities.

SECTION 3: ARTICLE X – RESIDENTIAL DISTRICTS, Section 10.04. R-3, Single-Family and Two-Family Residence District; subsection (c) *Special uses*, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language and deleting the stricken language, as follows:

10.04. R-3, Single-Family and Two-Family Residence District.

(c) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

(2) Bed and Breakfast facilities Establishments and Short-Term Rentals, licensed and regulated in accordance with the applicable provisions of the City of Peru Code of Ordinances.

SECTION 4: ARTICLE X – RESIDENTIAL DISTRICTS, Section 10.05. R-4, General Residence District; subsection (c) *Special uses*, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language and deleting the stricken language, as follows:

10.05. R-4, General Residence District.

(c) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

(2) Bed and Breakfast <u>facilities</u> <u>Establishments and Short-Term Rentals</u>, <u>licensed and regulated in accordance with the applicable provisions of the City</u> of Peru Code of Ordinances.

SECTION 5: ARTICLE XI - BUSINESS DISTRICTS, Section 11.02. B-1, Neighborhood Shopping District; subsection (d) *Special uses*, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language, as follows:

11.02. B-1, Neighborhood Shopping District.

(d) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

(6) Bed and Breakfast Establishments and Short-Term Rentals, licensed and regulated in accordance with the applicable provisions of the City of Peru Code of Ordinances.

SECTION 6: ARTICLE XI - BUSINESS DISTRICTS, Section 11.03. B-2, Community Shopping District; subsection (d) *Special uses*, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language, as follows:

11.03. B-2, Community Shopping District.

(d) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

11.05. B-4, Highway Business District.

(d) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

(27) Bed and Breakfast Establishments and Short-Term Rentals when located south of Shooting Park Road, licensed and regulated in accordance with the applicable provisions of the City of Peru Code of Ordinances.

SECTION 9: ARTICLE XII - MANUFACTURING DISTRICTS, Section 12.03. M-2, Manufacturing District; subsection (d) *Special uses*, of the City of Peru Zoning Ordinance No. 3817 shall be and is hereby amended by adding the underlined language, as follows:

12.03. M-2, Manufacturing District.

(d) Special uses. The following uses are allowed as special uses when authorized by the City Council, subject to the standards set forth in Section 15.12 of this Ordinance:

(5) Bed and Breakfast Establishments and Short-Term Rentals when located above the first floor and located south of 4th Street, licensed and regulated in accordance with the applicable provisions of the City of Peru Code of Ordinances.

AN ORDINANCE GRANTING A SPECIAL USE AS SOUGHT BY THE PETITION OF FRANCISCO SANDOVAL d/b/a PITA REY ESTATES LLC CONCERNING PROPERTY LOCATED AT 4 CENTER PLACE, PERU, ILLINOIS

WHEREAS, after legal ad notice duly published in the News Tribune in the manner provided by law, the Planning/Zoning Commission of the City of Peru conducted a public hearing on April 19, 2023, to consider the Petition of Francisco Sandoval d/b/a Pita Rey Estates LLC ("Petitioner") concerning property commonly known as 4 Center Place in the City of Peru, Illinois, legally described as follows:

Lot Eight (8) in Westclox Addition to Peru, according to the Plat thereof recorded 14 August, 1936 in Plat book "O", page 76, located in the City of Peru, in Section Sixteen (16), Township Thirty-three (33) North, Range One (1) East of the Third Principal Meridian, except coal and minerals and the right to mine and remove the same, situated in LaSalle County, Illinois.

PIN #: 17-16-253-016 ("Property"); and

WHEREAS, the Property is zoned R-3 Single and Two-Family District; and

WHEREAS, Petitioner desires to offer the Property as a short-term rental though Airbnb and similar websites and requests a special use pursuant to Section 10.04(c)(2) of the City's Zoning Ordinance; and

WHEREAS, the Planning/Zoning Commission has made its report of the hearing and has unanimously recommended that the City Council approve the requested special use.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: The City Council finds as facts the recitals hereinbefore set forth.

SECTION 2: The Subject Property is hereby granted a special use for "Bed and Breakfast Establishments and Short-Term Rentals, licensed and regulated in accordance with the applicable provisions of the City of Peru Code of Ordinances" pursuant to Section 10.04(c)(2) of the City's Zoning Ordinance.

The aforementioned special use is granted on the express condition that Petitioner and the Property maintain full compliance with all existing and future City codes, ordinances, and regulations. The special use is exclusive to Petitioner and the Property.

Nothing in this Ordinance shall be construed to allow for the operation of a Bed and Breakfast Establishment or Short-Term Rental without a valid license approved by the City Council, or to preempt any private covenants and restrictions that may be applicable to the Property.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval according to law.
