

ORDINANCE NO. 6753

**AN ORDINANCE AMENDING ORDINANCE NO. 6537
ENTITLED: “AN ORDINANCE FIXING WAGES FOR FULL-TIME, SWORN POLICE
DEPARTMENT EMPLOYEES OF THE CITY OF PERU, ILLINOIS COMMENCING
MAY 1, 2021 AND ENDING APRIL 30, 2024”**

WHEREAS, on February 15, 2021, the City Council of the City of Peru, an Illinois home rule municipal corporation, (hereinafter “City”) duly passed and adopted Ordinance No. 6637 entitled “An Ordinance Fixing Wages for Full-Time, Sworn Police Department Employees of the City of Peru, Illinois commencing May 1, 2021 and Ending April 30, 2024” (hereinafter “Wage Ordinance”); and

WHEREAS, the City Council of the City concurs that for fiscal year 2024 there shall be revisions within Exhibit A.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, LASALLE COUNTY, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

AMENDMENT: The Wage Ordinance shall be, and is hereby amended to read in its entirety as follows:


SECTION 1: The Wage Ordinance is hereby amended to revise the compensation for Police Command Staff and Patrol Sergeants.

SECTION 2: EFFECTIVE DATE: That this ordinance shall take effect May 1, 2023.


