The City of Peru is excited to announce that the event will be hosted once again in Peru at Centennial Park after a 13-year absence! With possible attendance of up to **1,000 visitors** or more, you are positioned better than ever to showcase yours crafts!

The Craft Village will be open Friday, August 6th 3pm-9pm; Saturday, August 7th, 10 am - 9 pm and Sunday, August 8th 10am-4pm. Vendors will be open for business during all hours previously listed unless they are given permission to leave due to inclement weather. Vendors move--in and set--up will be Friday afternoon from 12pm-3pm.

Note: All vendors must adhere to set-up schedules due to road / festival closures for safety and security. Absolutely no vehicles allowed to enter/exit from festival grounds once street closures are in place.

If you plan to participate, please provide a description of your display and description of the products you intend to sell to be reviewed by the Taste of the Illinois Valley Committee. The Committee reserves the right to accept vendors and assign spaces. If electricity is required, you must request in advance.

Due to space constraints, limited electricity, and duplicate items, the committee reserves the right to deny application at which time payment and application will be returned. Vendor fees are required to be submitted with this application. No refunds for any reason. Vendors are responsible for providing their own tent, tables, and chairs. Vendors are responsible for the set-up and clean-up of their booths. WHEREAS, If Indemnitor is approved by City to participate in the Festival, City requires protection against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, legal fees and costs of any kind or amount whatsoever that may result from Indemnitor's activities or participation in the Festival.

NOW THEREFORE, it is hereby agreed that, in consideration and as a condition of Indemnitor's participation in the Festival, Indemnitor shall indemnify and hold harmless City, its officers, agents, employees, elected officials, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, legal fees, and costs of any kind or amount whatsoever, which result from Indemnitor's activities or participation in the Festival, which shall include, but not be limited to, any negligent, willful, wanton, or intentional acts or omissions made by or on behalf of Indemnitor, its agents, employees, or assignees, and shall further include the payment of Illinois Sales Tax on gross receipts unless Indemnitor is properly exempted.
