CITY OF PERU REGULAR COUNCIL MEETING FEBRUARY 4, 2019

A regular meeting of the Peru City Council was called to order by Mayor Scott J. Harl in the Peru City Council Chambers on Monday, February 4, 2019 at 7:00 p.m.

City Clerk Dave Bartley called the roll with Aldermen Potthoff, Ferrari, Waldorf, Lukosus, Radtke, Sapienza, Payton and Ballard present; Alderman Ferrari left at 7:15 p.m.; Mayor Harl present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

PUBLIC COMMENT

PRESENTATION

Mayor Harl presented information regarding a decorative clock that will be placed outside the front door of the Municipal Building. Mayor Harl noted the good fortune to have a singular donor to pay for the clock. Mayor Harl stated the clock is quite substantial and has many fine features including music and different chimes. Harl said. "It has what the Verdant Clock Company calls the town crier option. For instance, at the holidays, you can play holiday music." The clock will be 16 feet and 8 inches tall.

Mayor Harl thanked Mr. Joe Hogan on behalf of the former Mayor Don Baker and his wife Anne. Mr. Hogan spoke in favor of the clock and thanked Mayor Harl. Mr. Hogan also noted the clock was gifted to the city by former Mayor Don and Anne Baker and will be of no expense to the City. The clock will have a plaque honoring former Mayor Baker. The clock will arrive in May or June, and the city's electric department will install it.

MINUTES

Mayor Harl presented the minutes of the Regular Meeting of January 21, 2019. Alderman Potthoff made a motion that the minutes be received and placed on file. Alderman Waldorf seconded the motion; motion carried.

FINANCIAL REPORTS

Mayor Harl presented the Treasurer's Report for December 2018; City Clerk's Report of Cash Received for December 2018; General Fund and Miscellaneous Funds Report for December 2018; Sales, Home Rule, Use and Telecommunication Tax Receipts for October 2018 and Utility Fund Report for December 2018. Alderman Potthoff made a motion the reports be received, placed on file. Alderman Potthoff noted the sales tax figure and stated the importance of sales tax and economic development. Alderman Waldorf seconded the motion; motion carried.

ACTIVITY REPORTS

Mayor Harl presented the Peru Police Department 2018 Annual Report; Peru Volunteer Ambulance Service Inc. Activity Summary for December 2018 and Peru Volunteer Ambulance Service Inc. Activity Summary for Year 2018. Mayor Harl read the letter from Police Chief Doug Bernabei on the cover of the 2018 Annual Report. Alderman Potthoff spoke in favor of the detailed report and noted the community police and involvement. Alderman Waldorf made a motion the reports be received and placed on file. Alderman Lukosus seconded the motion; motion carried.

Alderman Radtke made a motion that the report be received, placed on file and the bills be paid in the usual manner. Alderman Payton seconded the motion. City Clerk Dave Bartley called the roll with Aldermen Potthoff, Waldorf, Lukosus, Radtke, Sapienza, Payton and Ballard voting aye; Alderman Ferrari absent; motion carried.

PUBLIC SERVICES COMMITTEE

Alderman Waldorf made a motion to approve an engineering service agreement for the Unytite Drive extension noise study, as requested by the FHWA, with Prairie Engineers not to exceed \$20,000. (The Unytite Drive project is in the heart of the City of Peru's Industrial corridor, which contains many industry users, including a rail transload facility, distribution centers, and large manufactures). Alderman Lukosus seconded the motion. City Clerk Dave Bartley called the roll with Aldermen Potthoff, Waldorf, Lukosus, Radtke, Sapienza, Payton and Ballard voting aye; Alderman Ferrari absent; motion carried.

Alderman Waldorf made a motion to approve an engineering service agreement for the North Peoria roadway noise study, as requested by the FHWA, with Prairie Engineers not to exceed \$42,000. (The N. Peoria Roadway project consists of the improvement of existing roadways. A small portion of those roadways are being re-aligned to an area further away from the residential areas it abuts today). Alderman Sapienza seconded the motion. City Clerk Dave Bartley called the roll with Aldermen Potthoff, Waldorf, Lukosus, Radtke, Sapienza, Payton and Ballard voting aye; Alderman Ferrari absent; motion carried.

Mr. Mike Perry of Chamlin and Associates stated both of the studies are required due to federally funding requirements.

PUBLIC COMMENT

Ms. Julie Ajster asked for clarification of the sign ordinance regarding the removal of political signs from fences or free-standing structures.

Ms. Julie Ajster voiced her concerns regarding the donation of the clock and questioned the timing of the donation. Ms. Ajster commented on the zoning, variance, and text amended granted by the City for the Casey's property which was sold by Anne Baker. Ms. Ajster noted the significant sale price of the property compared to its assessed value. Ms. Ajster noted the Attorney General's comments regarding the procedures of the Planning and Zoning Board. Ms. Ajster wondered out loud if the donation was somehow a pay for play political gift.



Officer Brown scene with his squad's emergency lights activated while the vehicle was extracted from the ditch.

A passing motorist failed to yield to Officer Brown's emergency vehicle and ultimately lost control of her own vehicle, resulting in a collision with the tow truck on scene. Officer Brown's quick decision making skills led him to grab ahold of a citizen directly in the path of the out of control vehicle and get him out of harm's way. Officer Brown's act was selfless, and he left himself in the path of the vehicle instead of the citizen. Officer Brown's actions this evening displayed his commitment to serve and protect the citizens in Peru.

Thankfully, both Officer Brown and the citizen were both left unharmed. The outcome could have potentially led to serious bodily injury or worse if Officer Brown would not have acted as expeditiously as he did. I believe Officer Brown deserves recognition for his life saving deed and his ability to make quality split second decisions under pressure.



Pursuant to legal notice published in the News Tribune on January 26, 2019 in the manner provided by law, the Planning/Zoning Commission of the City of Peru, IL (hereinafter "City") convened for a public hearing on Wednesday, February 13, 2019, at 5:30 p.m. in the City Municipal Building, 1901 Fourth Street, Peru, IL, to consider the Petition of Relay for Life of Upper Illinois Valley (hereinafter "Petitioner") praying for variances under the terms of the Zoning Ordinance of the City as it applies to the First State Bank real estate located at 4351 Venture Drive, Peru, IL, legally described as follows:

Lot Two (2) in Toedter's Third Addition to the City of Peru, being a part of the East Half of the Northeast Quarter of Section 5, Township 33 North, Range 1, East of the Third Principal Meridian, according to the Plat thereof record April 20, 1993 as Document No. 93-05782, excepting underlying coal and minerals with the right to mine and remove the same without entering upon the surface, situated in LaSalle County, Illinois (hereinafter "Property")

The Petitioner requests the following sign variances, to wit: (a) allow the sign to be displayed from April 15, 2019 to July 15, 2019 as a variance to Section 8.06(g)(4) of the Zoning Ordinance; (b) allow the promotion of an off premises event for a cancer charity campaign pursuant to Section 8.06(g)(3) of the Zoning Ordinance; (c) allow the sign to be as close to the IL Route 251 right-ofway as possible pursuant to Section 8.06(g)(2); and (d) for such other and further relieve as may be appropriate. Additional variances required by Petitioner include: (e) displaying the approximately 4'x9'sign (36 square feet) as a variance to the maximum 32 square feet allowed under Section 8.06(g)(6), and (f) allowing the approximately 10' high sign as a variance to the 5' maximum height a'lowed under Section 8.06(g)(7). The Property is located within an B-2 Community Shopping District.

Planning/Zoning Members Miller, Atkinson, Lucas, Brady and Moreno were present at the hearing. Members Grabowski and Kalsto were absent.

Mitch Landgraf, after being first duly sworn, stated that he is a volunteer with Petitioner and the Chairperson for Petitioner's March to a Million fundraising campaign. Mr. Landgraf stated this marks the 10th year Relay for Life has fundraised for the American Cancer Society in the upper Illinois Valley area. The campaign has raised over \$875,000 over the course of the first nine years, and Petitioner's "March to a Million" campaign seeks to reach \$1,000,000 this year. Petitioner seeks variances to allow for a temporary nonprofit special event sign on the First State Bank Property to promote the March to a Million campaign and track progress towards the \$1,000,000 goal.

Mr. Landgraf testified further that Petitioner has been granted permission by First State Bank President Tim McConville to place the approximately 4'x10' sign on the Property. The sign will be professionally made by MCS Advertising in Peru and will be water-resistant. It will be attached to two wooden ground posts. Petitioner seeks to display the sign from April 15, 2019 through July 15, 2019. The sign will be removed at that time regardless if Petitioner meets its fundraising goal.

In response to questioning from Chairman Miller, Mr. Landgraf indicated that the sign is designed to be approximately 4'x9' in size. With minimal ground clearance, the sign should not exceed ten feet in height.

In response to Member Atkinson concerning the placement of the sign off of the Illinois Route 251 right-of-way, City Engineer Eric Carls stated that the right-of-way is 100' from the roadway centerline. Carls further stated that there would be no line of sight issues so long as the sign was placed on the Property.

No objectors were present at the hearing.

Planning/Zoning Commission Member Lucas moved and Planning/Zoning Commission Member Moreno seconded to favorably recommend to the City Council that Petitioner receive a variance for the approximately 36 square feet sign from the maximum 32 square feet allowed under Section 8.06(g)(6), The motion passed, 5 aye, 0 nay and 2 members absent.

Planning/Zoning Commission Member Lucas moved and Planning/Zoning Commission Member Brady seconded to favorably recommend to the City Council that Petitioner receive a variance for the approximately 10' high sign from the maximum 5' height allowed under Section 8.06(g)(7). The motion passed, 5 aye, 0 nay and 2 members absent.

Planning/Zoning Commission Member Brady moved and Planning/Zoning Commission Member Atkins seconded that the remaining variances requested in the Petition be recommended to the City Council favorably. The motion passed, 5 aye, 0 nay and 2 members absent.

Demand Response Sales and Services Agreement

This Demand Response Sales and Services Agreement (this "Agreement"), effective as of .______ ("Effective Date"), the scope of which is described more fully below, is made by and between Illinois Municipal Electric Agency ("IMEA"), City of Peru ("Municipal Utility"), and James Hardie Building Products, Inc. ("Customer"). IMEA, Peru and Customer are defined herein as the Parties ("Parties") to this Agreement.

1. Term. This Agreement shall commence on the Effective Date and end May 31, 2019 (the "Initial Term").

2. Demand Response Services

•

- a. Scope of IMEA Services. IMEA agrees to manage Customer's participation in the demand response and/or capacity program(s), as further described in <u>Attachment A-1</u> attached hereto (each individually the "Program" and collectively, the "Programs"), in accordance with the rules of the applicable Regional Transmission Organization ("RTO") and/or utility, which are subject to amendment by the RTO or utility from time to time. IMEA will perform the following functions:
 - (I) work with Customer to develop an appropriate curtailment plan for Customer's facilities;
 - (II) register/bid Customer's Nominated Capacity (as defined in <u>Attachment A-1</u>) into the demand response program and/or use such capacity directly to meet the capacity obligations of IMEA and its Member municipal utilities under the RTO rules;
 - (iii) notify Customer of its Committed Capacity (as defined in <u>Attachment A-1</u>) that is subject to the Programs;
 - (iv) manage Customer's curtailable electrical capacity in the Programs, including but not limited to receiving all communications from MISO and providing notification to Customer to generate and/or reduce electrical demand during demand response events ("Demand Response Events"): and
 - (v) reconcile all Program payments in accordance with the RTO rules and as further described in Attachment A-1.
- b. Optional Additional Service. If appropriate metering is installed and operational for Customer's facilities, or if the Municipal Utility makes such metering available at Customer's request and expense, IMEA will coordinate with the Municipal Utility to capture kilowatt-hour (kWh) pulses from the Customer's primary utility meter to provide Customer near real-time, Internet-enabled power monitoring.
- c. Municipal Utility Service. Municipal Utility will allow Customer to utilize its connection to the municipal electric distribution system to participate in the Programs and will provide support to Customer in connection with all metering, interconnection and billing issues that may arise during this Agreement. Municipal Utility will provide upgraded metering equipment and data communication services (if needed) at Customer's expense if requested by Customer.
- d. IMEA Communications Equipment. IMEA, as it deems necessary and at its sole option, may equip one or more of Customer facilities (each a "Site Address") as identified on Attachment A-2 hereto with IMEA communications equipment.

3. Customer Support Requirements

- a. Representations and Warranties. Customer represents and warrants that it holds all applicable licenses and/or permits that are required for the proper participation in the Program, including any local licenses and/or permits necessary to utilize on-site electric generation. Customer further represents and warrants that it has the intent and ability to generate and/or reduce electrical demand to achieve Nominated and Committed Capacity at each Site Address when notified by IMEA during Demand Response Events.
- b. General Support Requirements. Customer shall provide or cause to be provided to IMEA and/or Municipal Utility in a timely manner all information required by the RTO to approve the demand response resources for inclusion into the Demand Response program or capacity auction and any and all other information reasonably requested by the Municipal Electric Utility and IMEA in connection with their evaluation of the resources and their participation in the program or auctions. Customer shall provide IMEA with all information reasonably requested by IMEA or necessary for IMEA to comply with the rules, regulations, business practices and any other requirements of the RTO in connection with the programs.
- c. Communications Equipment Installation. Customer shall provide access to its facilities for Installation of IMEA's communications equipment, if any, and either a static or non-static, as applicable, Internet Protocol (IP) address and Local Area Network (LAN) access that allows IMEA to monitor, via Internet-based communication, the facilities' electricity consumption and Demand Response Event performance.
- d. Acceptance Testing. Customer agrees to collaborate with IMEA and the Municipal Utility in testing the metering equipment and IMEA communications equipment, if any, at each Site Address.
- e. Event Performance. Customer agrees to use commercially reasonable efforts to generate and/or reduce electrical demand to achieve its Committed Capacity level as defined in <u>Attachment A-1</u> at each Site Address

when notified by IMEA during Demand Response Events.

- Use of Confidential Information. Customer acknowledges that IMEA may receive Confidential Information f. of Customer, either through data collected by the IMEA System or otherwise, which may be disclosed by IMEA to the RTO and/or utility as necessary for the performance of this Agreement.
- Service Provider Limitation. Customer agrees not to contract with any other demand response service g. provider for the Term of this Agreement.

4. Payments.

- Metering Equipment Fees. For each Site Address where upgraded metering equipment is requested by а. Customer, Customer shall pay to the Municipal Utility a one-time fee equal to the actual cost of the metering equipment and monthly for data communication services (if needed).
- Demand Response Payments. In connection with Customer's participation in the Programs, IMEA will make ь. payments to the Municipal Utility and the Municipal Utility shall make payments to Customer in the amounts and in accordance with the payment terms set forth in the Program Rule Attachment(s).

- Limitation on Liability. IMEA's liability, and the liability of the Municipal Utility, hereunder is limited to direct actual damages as the sole and exclusive remedy, and total damages shall not exceed the lesser of (i) the 8. total amount paid to Customer under this Agreement during the six-month period immediately preceding the event giving rise to the claim(s) or (ii) \$10,000. All other remedies or damages (at law, in equity, tort, contract, or otherwise) are expressly waived, including any indirect, punitive, special, consequential, or incidental damages. lost profit, or other business interruption damages.
- Choice of Law and Venue. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Illinois, without giving effect to choice of law rules. The only appropriate venue b. and forum for the resolution of disputes hereunder shall be the State circuit court of the county in which the Municipal Utility is located.

Attachment A-1 IMEA Demand Response – MISO LMR Demand Resource

- IMEA Program General Description. IMEA has a Demand Response Program to provide incentives for end user customers who have demand response resources on the distribution systems of IMEA Members to use those resources to help reduce the need for capacity and energy during times when it would be economical or beneficial to the national/regional transmission grid to reduce load.
- 2. MISO Program General Description. Load Serving Entitles ("LSEs") in region controlled by Midcontinent Independent System Operator, Inc. ("MISO") are subject to an annual capacity obligation based on their peak loads plus reserves. MISO manages a voluntary capacity auction as one means of meeting the capacity obligation. Under MISO's Tariff and rules, qualifying demand response resources can be sold into the MISO capacity auctions or purchased and sold bilaterally and used to meet capacity obligations. MISO's current rules for demand response resources is found in Business Practice Manual 26, revision 2, dated and effective July 1, 2017.
- 3. IMEA Program Rules. The terms of this Agreement reflect the current terms and conditions for demand response resources qualifying to be used to meet capacity obligations under MISO's Load Modifying Resource provisions. MISO's terms and conditions are subject to amendment from time to time in accordance with the Federal Power Act. The current terms and conditions for LMR Demand Resources are as follows:

	MISO Plenning Year 2018/2019; June 1, 2018 - May 31, 2019
Delivery Year	The Demand Resource must be capable of reducing load and commit to a load
Minimum Resource Size	reduction level equal to or greater than 100 kW.
Curtailment Period	June 1 - August 31 of the Delivery Year.
Program Hours	Resources must be available to respond during the twenty four (24) hour period beginning at 0000 hours EST any day of the week during the Curtailment Period.
Event Trigger	MISO will initiate Demand Response events in the case of a system emergency, defined in Schedule 30 of the MISO Tariff as NERC Energy Emergency Alert 2 ("EEA2"), Alert 3 ("EEA3"), or any other types of Emergency events. References, within Schedule 30, to Emergency events include both Transmission System and capacity Emergencies.
	The Demand Resource must be available to be scheduled for a Demand
Advanced Notification	reduction at the targeted Demand reduction level or by moving to a specified firm service level with no more than 12 Hours advance notice from MISO to IMEA.
Timing of Demand Reduction	Once Scheduling Instructions are given by MISO that require a Demand reduction, the Demand Resource must be capable of ramping down to meet the targeted Demand reduction level or achieve the firm service level by the Hour designated by MISO's Scheduling Instructions.
Duration of Event	Once the targeted level of Demand reduction or firm service level is achieved, the Demand Resource must be able to maintain the targeted level of Demand reduction or firm service level continuously for at least four (4) consecutive hours.
Event Frequency	The Demand Resource must be capable of being interrupted at least the first five (5) times during the Curtailment Period when called upon by MISO, not including any test events.
Testing Requirement	MISO requires a load-shedding test of each resource when the resource is first registered and once per year thereafter. If a called event qualifies as the annual test, then no separate test event will be required. If there are no called events that qualify as the annual test, then a test event will be called by IMEA at its discretion.

4. Demand Response Event Performance

- a. Method of Notification. Customer shall provide a primary and secondary contact person's name and contact information at the facility location and information for notification of RTO called Demand Response Events on Attachment A-2. If the primary and secondary contacts at the facility are unavailable at the same time, Customer will provide another responsible contact for the time period when the primary and alternative contacts are unavailable as soon as possible. IMEA will forward MISO notifications of a called event electronically to an e-mail address and/or an e-mail addressable device (I.e., text pager or cell phone), notifying Customer's primary and when an event is called.
- b. Performance by Customer. Customer is required to reduce its electric load requirements during each called Demand Response Event up to the number of events identified above.
- c. Metering. The Municipal Electric Utility shall submit monthly hour by hour revenue quality metering data from Customer's demand response resources to IMEA within 30 days after the end of June, July and August or after a called event that occurs in a month other than June, July or August. The Municipal Electric Utility will submit metering data to IMEA to allow IMEA to have the RTO calculate the performance of Customer's demand response resources during a called Demand Response Event.

5. Customer Capacity

•

- d. Nominated Capacity. For purposes of this Agreement, "Nominated Capacity" shall represent the best estimate of Customer's performance based on analysis of consumption data and pre-enrollment testing. Customer agrees that the Nominated Capacity may be adjusted by IMEA in the future to reflect actual performance, changes in facility operations, Program rules, regulations and/or other relevant information. The Site name, address and Nominated Capacity of each of Customer's facilities is shown on <u>Attachment A-2</u>, which may be updated in writing from time to time by the Parties to reflect additional Site Addresses.
- e. Committed Capacity. For purposes of this Agreement, "Committed Capacity" will equal the demand response capacity that either clears in the MISO auction or that is used directly by IMEA to meet its capacity obligation under the MISO rules. Measurement for testing and performance will be based on the Customer's consumption baseline that is determined by MISO and the firm service level to which the Customer agrees to reduce its demand for a Demand Response event.

6. Payments

- a. Capacity Payments. IMEA will pay the Municipal Utility \$1.20/kW-month of Customer's Committed Capacity for each month of the Delivery Year minus any MISO charges or penalties.
- b. Underperformance. Customer shall bear the sole responsibility for any MISO charges or penalties imposed as a result of underperformance or non-performance.
- c. Payment Timing. IMEA shall make the initial Capacity Payment associated with Customer's participation in the Program for the first 3 months of the Delivery Year (adjusted for any penalties and/or charges that are the Customer's responsibility) to Municipal Utility by means of a credit on the Municipal Utility's bill from IMEA. The initial payment from IMEA shall be made following the end of the Curtailment Period and after the determination by MISO, if any, of penalties and/or charges associated with underperformance by Customer. The Municipal Utility shall retain 0% of the initial Capacity Payment and shall credit the remainder thereof to Customer on its next bill from the Municipal Utility. The remainder of the Capacity Payments associated with Customer's Committed Capacity minus any remaining penalties and/or charges shall be paid in the same manner to the Municipal Utility by IMEA and to Customer by the Municipal Utility in equal monthly [quarterly] installments thereafter.

1. PROJECT SCHEDULE

For the purposes of this agreement, the start date will be the date the agreement is executed by the Agency and the complete date will be the date of final repayment. Any obligation of the State of Illinois and the Agency to make any disbursement of loan funds shall terminate unless this project work is initiated and completed in accordance with the schedule contained in the Loan Agreement.

2. AVAILABILITY OF APPROPRIATIONS; SUFFICIENCY OF FUNDS

This Loan Agreement is contingent upon and subject to the availability of sufficient funds. The Agency may terminate or suspend this Loan Agreement, in whole or in part, without penalty or further disbursements being required, if (i) sufficient State funds have not been appropriated to the Agency or sufficient Federal funds have not been made available to the Agency by the Federal funding source, (ii) the Governor or the Agency reserves appropriated funds, or (iii) the Governor or the Agency determines that appropriated funds or Federal funds may not be available for payment. The Agency shall provide notice, in writing, to the loan recipient of any such funding failure and its election to terminate or suspend this Loan Agreement as soon as practicable. Any suspension or termination pursuant to this Section will be effective upon the loan recipient's receipt of notice. Should the Agency terminate or suspend this Loan Agreement as described above, the loan recipient shall still be required to repay to the Agency in accordance with this Loan Agreement the total amount of loan disbursements made by the Agency.

3. DISBURSEMENTS

Disbursement requests for project work will be processed based on costs incurred, subject to the appropriation of funds by the Illinois General Assembly. Such disbursement requests shall be submitted quarterly and will be monitored for compliance with applicable state and federal laws and regulations, including Section 705/4(b)(2) of the Illinois Grant Funds Recovery Act (30 ILCS 705), and shall constitute quarterly reports as required therein by describing the progress of the project and the expenditure of the loan funds related thereto. Any loan funds remaining unexpended in the project account after all application loan conditions have been satisfied and a final loan amendment has been executed shall be returned to the State within forty-five (45) days of the execution date on the final loan amendment. If the loan recipient reimburses their contractor(s) prior to requesting funds from Illinois EPA, the Loan Recipient shall request as quickly as possible, but in no event later than dictated by Section 5 of the submitted Tax Compliance Certificate and Agreement, reimbursement from the Agency.

4. REPAYMENT SCHEDULE – Nature of Obligations, Fixed Loan Rate, Interest, Loan Support, Principal Payments and Principal Forgiveness.

a) In accordance with Ill. Adm. Code 365.210, the fixed rate is comprised of interest and loan support, both of which are established annually. The term "interest" is used in this Loan Agreement as well as future correspondence, repayment schedules, etc. to reflect both interest and loan support.

b) This Loan Agreement has been issued and entered into pursuant to an authorizing ordinance of the loan recipient. The recipient recites that it has taken all required actions to enter into the Loan Agreement and has complied with all provisions of law in that regard.

c) By this Loan Agreement, the loan recipient agrees to repay to the Agency (or, upon notice by the Agency to the loan recipient, the Agency's assignee) the principal amount of the loan with interest on the outstanding and unpaid principal amount of the loan from time to time until repaid in full, all as provided in this Loan Agreement.

d) For purposes of determining the repayment amount, the principal amount of the loan shall be the total amount of loan disbursements made by the Agency under this Loan Agreement, plus interest treated as principal as provided in paragraph (g) below,

less the amount of principal forgiveness as may be defined in the special condition(s) of this loan agreement. The amount financed shall not exceed the amount identified in the approved authorizing ordinance.

e) The final principal amount will be determined by the Agency after a final disbursement request and project review have been made to ensure all applicable loan conditions have been satisfied.

f) Simple interest on each loan disbursement will begin on the day after the date of the issuance of a warrant by the Comptroller of the State of Illinois.

g) Interest and principal on the loan will be due on the dates and in the amounts as set forth in repayment schedules provided for in this paragraph. Upon the initiation of the loan repayment period, the Agency shall establish and notify the loan recipient of an interim repayment schedule in accordance with the terms of this loan. After the Agency conducts the final review of the costs of the project to establish the final principal amount, the Agency shall establish and notify the loan recipient of a final repayment schedule. For purposes of calculating the repayment schedules, the Agency shall consider principal of the loan to consist of all unrepaid disbursements plus all unrepaid interest accrued on these disbursements at the time the schedule period begins. Each of these repayment schedules shall provide for repayment installments consisting of principal plus simple interest on the unpaid principal balance. The installment repayment amount may change when the interim repayment schedule is replaced by the final repayment schedule.

h) Interest on each loan disbursement shall be calculated on the basis of the total number of days from the date the interest begins to accrue to the beginning of the repayment period and will be calculated on a daily basis using a 365 day year. All interest due on the principal of the loan during the repayment period is calculated on a periodic basis.

i) The Loan Agreement shall be subject to prepayment at any time in whole or in part, at the option of the loan recipient, by payment of the outstanding principal plus accrued and unrepaid interest on that principal accrued to the date of prepayment.

5. MODIFIED OR SUBSEQUENT ORDINANCES

The ordinance authorizing entry into this Loan Agreement or dedicating the source of revenue shall not be amended or superseded substantively or materially without the prior written consent of the Agency.

6. DBE REPORTING REQUIREMENTS

The loan recipient is required to comply with the Disadvantaged Business Enterprise (DBE) reporting requirements as established and mandated by federal law and implemented in federal code: 40 CFR Part 33. Compliance with the code will necessarily involve satisfaction of the six (6) good faith efforts as set forth in the federal DBE program, and will require the use of the particular contract specifications and language for advertising of the project. More information and guidance on the DBE requirements is available on the IEPA web site.

7. COMPLIANCE WITH ACT AND REGULATIONS

The Agency shall not make any payments under this loan offer if the construction project has been completed and is being operated in violation of any of the provisions of the Clean Water Act, Environmental Protection Act (415 ILCS 5/1 et seq.) or Water Pollution Control Regulations of Illinois (Title 35: Subtitle C: Chapter I: Pollution Control Board Regulations and Chapter II: Agency Regulations) adopted thereunder.

8. CONSTRUCTION COMPLETION - FINAL INSPECTION

The loan recipient shall notify the Agency's Infrastructure Financial Assistance Section's (IFAS) Post Construction Unit in writing within 30 days from the construction completion date and shall submit the final change order, along with the contractor's final costs. Within 90 days from the construction completion date the loan recipient shall forward one (1) copy of the final plans of record to the appropriate Agency regional field office and one (1) copy to the Agency's IFAS Post Construction Unit. In addition, a completed "Certificate Regarding O & M" (available on the Agency website) shall be sent to the Agency's IFAS Post Construction Unit. The regional field office may contact the loan recipient to schedule a final inspection following submittal of the final plans of record.

9. OPERATION AND MAINTENANCE OF THE PROJECT

The Agency shall not approve the final loan closing for the project unless the loan recipient has certified that the training and operation and maintenance documents have been provided in accordance with 35 Ill. Adm. Code 365.460.

10. FLOOD INSURANCE

Evidence must be provided that flood insurance has been acquired on eligible structures constructed under this Loan Agreement as soon as structures are insurable.

11. DELINQUENT LOAN REPAYMENTS

a) In the event that a repayment is not made by a loan recipient according to the loan schedule of repayment, the loan recipient shall notify the Agency in writing within 15 days after the repayment due date in accordance with 35 Ill. Adm. Code 365.510 Delinquent Loan Repayments.

b) After the receipt of this notification, the Agency shall confirm in writing the acceptability of the loan recipient's response or take appropriate action.

c) In the event that the loan recipient fails to comply with the above requirements, the Agency shall promptly issue a notice of delinquency which requires a written response within 15 days.

d) Failure to take appropriate action shall cause the Agency to pursue the collection of the amounts past due, the outstanding loan balance and the costs thereby incurred, either pursuant to the Illinois State Collection Act of 1986 (30 ILCS 210) or by any other reasonable means as may be provided by law.

12. SINGLE AUDIT ACT

If the dedicated source of revenue is pledged in a subordinate position to an existing revenue bond ordinance, the covenants regarding coverage and reserve shall be in accordance with 35 Ill. Adm. Code 365.350(a)(10)(C).

15. RECORDS RETENTION

The loan recipient agrees to establish and maintain the books and other financial records pertaining to this project in accordance with Generally Accepted Accounting Principles as issued by the Governmental Accounting Standards Board (GASB), including standards relating to the reporting of infrastructure assets per GASB Statement No. 34. The loan recipient shall maintain all books and records pertaining to this project for a period not less than 3 years from the date of the final loan closing. All records pertaining to the issuance of bonds and the repayment of this loan shall be maintained for a period not less than 3 years from the final repayment date. The loan recipient agrees to permit the Agency or its designated representatives, including the Illinois Auditor General and the Illinois Attorney General, to inspect and audit the books and financial records pertaining to the project and the expenditure of the loan funds related thereto.

16. CONTINUING DISCLOSURE

The recipient covenants and agrees that, if at any time the Agency shall notify the recipient that the recipient is deemed to be an "obligated person" for purposes of Rule 15c2-12 adopted by the Securities and Exchange Commission under the Securities Exchange Act of 1934 (the "Rule"), the recipient shall promptly execute an undertaking in form acceptable to the Agency in compliance with the Rule in which the recipient shall agree, among other things, to provide annual financial information (as defined in the Rule) with respect to the recipient to all required information repositories for so long as the recipient shall be deemed an obligated person. The recipient shall be deemed to be an obligated person at any time the aggregate principal amount of one or more of the recipient's outstanding loans with the Agency, which are pledged to secure bonds issued on behalf of the Agency, exceeds a percentage (currently 20%) of the aggregate principal amount of all loans of the Agency pledged to secure such bonds.

17. WAGE RATE REQUIREMENTS

The loan recipient is required to comply with Wage Rate requirements established in rules issued by the U.S. Department of Labor to implement the Davis-Bacon Wage Act and other related acts (29 CFR Parts 1, 3 and 5). These rules require a number of specific actions by the federal funding recipient (the IEPA), the sub-recipient (the loan recipient) and the contractor, including payroll record certification and reporting as required. d) False Claims Act – Prompt referral to USEPA's Inspector General of any credible evidence of a false claim or criminal or civil violation of laws pertaining to fraud, conflict of interest, bribery, gratuity, or similar misconduct involving funds under this loan (Loan Recipient Only)

e) The Coastal Zone Management Act of 1972, 16 U.S.C. 1451 (Loan Recipient Only)

f) Section 504 of the Rehabilitation Act of 1973 - Prohibits exclusion and employment discrimination based on a disability.

g) Title VI of the Civil Rights Acts of 1964 - Prohibits discrimination or exclusion based on race, color, or national origin.

21. CERTIFICATION

By accepting this loan offer, the loan recipient certifies under oath that all information in the loan agreement and the related loan application is true and correct to the best of the loan recipient's knowledge, information and belief, and that the loan funds shall be used only for the purposes described in the loan agreement. This offer of loan funds is conditioned upon such certification.

22. FISCAL SUSTAINABILITY PLAN REQUIREMENTS

The loan recipient shall comply with the Fiscal Sustainability Plan (FSP) requirement contained in Section 603(d)(1)(E) of the Federal Water Pollution Control Act by submitting a certification that they have developed and implemented a FSP. This provision applies to all loans for which the borrower submitted a loan application on or after October 1, 2014. This determination letter is issued pursuant to section 9.5(f) of the Freedom of Information Act (FOIA) (5 ILCS 140/9.5(f) (West 2016)). For the reasons that follow, the Public Access Bureau concludes that the City of Peru (City) did not violate FOIA by charging a copying fee for paper copies in response to Ms. Julie L. Ajster's March 28, 2018, FOIA request.

On that date, Ms. Ajster, on behalf of a client, submitted a FOIA request to the City stating:

Pursuant to the Freedom of Information Act, I am requesting documents relating to the Dollar General Store located on Peoria Street in the City of Peru. I am requesting any and all documents relating to Dollar General and the acquisition of the property located at the corner of 6th and Peoria Streets from the City of Peru. I am also requesting copies of any and all emails, memos or other correspondence between Peru's Economic

On that same date, the City informed Ms. Ajster that "there [was] a substantial amount of information to copy," and asked whether she sought specific records or all records that the City had on file.² In reply, Ms. Ajster stated: "I need everything you have. If you need additional time, that is fine."³ On April 16, 2018, at 9:20 a.m., the City's FOIA Officer, Ms. Stephanie Piscia, notified Ms. Ajster: "I will have your documents ready today. There is a lot of information. I will have a dollar amount for you shortly and let you know when they are available."⁴ At 9:45 a.m. on that same date, Ms. Piscia notified Ms. Ajster: "I have your request ready for pickup. There is a total of 1554 documents. The total for the request is \$225.60."⁵

On June 15, 2018, this office received Ms. Ajster's Request for Review disputing the copying charge. She asserted that she had previously sent dozens of FOIA requests to the City and had received copies of the responsive records in an electronic format at no cost. She contended that the City violated FOIA by: (1) "charging [her] for photocopies of documents which should have been produced free of charge in electronic form[;]" (2) "repeatedly complaining in public and in the newspaper about FOIA requests[;]" (3) "not providing [her] with an estimate as to the cost of [her] FOIA request prior to preparing a FOIA response[;]" (4) "demanding [she] pick up the documents rather than mailing them to [her][;]" and (5) "stating to the News Tribune that the FOIA response was free when it is not and they are refusing to release

the documents until [she] pay[s] \$225.60."⁶ Ms. Ajster enclosed copies of news articles in which she stated, "the City of Peru was complaining about the number of FOIA requests."⁷

On June 25, 2018, this office forwarded a copy of the Request for Review to the City and asked it to address the allegations in Ms. Ajster's Request for Review. This office also asked the City to address the timeliness of its response to her request, and to clarify whether any of the requested records were maintained in an electronic format. On June 27, 2018, the City provided a written response and copies of its correspondence with Ms. Ajster regarding the request. On July 3, 2018, this office forwarded a copy of the City's response to Ms. Ajster; she did not reply.

DETERMINATION

"All records in the custody or possession of a public body are presumed to be open to inspection or copying." 5 ILCS 140/1.2 (West 2014); see also Southern Illinoisan v. Illinois Department of Public Health, 218 III. 2d 390, 415 (2006).

As an initial matter, the Public Access Counselor's authority to resolve disputes is limited to alleged violations of FOIA and the Open Meetings Act (5 ILCS 120/1 *et seq.* (West 2016)). *See* 15 ILCS 205/7(c)(3) (West 2016). FOIA governs the disclosure of existing public records; it does not dictate the manner in which a public body may comment to media outlets or the general public about FOIA requests it has received. Accordingly, this office is not authorized to review allegations concerning public statements that the City made regarding FOIA requests.

Turning to whether the copying fee that the City assessed was permissible, section 3(a) of FOIA (5 ILCS 140/3(a) (West 2016)) provides that "[e]ach public body shall make available to any person for inspection or copying all public records, except as otherwise provided in Sections 7 and 8.5 of this Act." Section 3(d) of FOIA (5 ILCS 140/3(d) (West 2016)) states that a public body shall "either comply with or deny a request for public records within 5 business days after its receipt of the request[.]" Section 3(d) further states that "[a] public body that fails to respond to a request within the requisite periods in this Section but thereafter provides the requester with copies of the requested public records may not impose a fee for such copies." Section 3(e) of FOIA (5 ILCS 140/3(e) (West 2016)) permits a public body to extend the time to respond by 5 business days from the original due date for any of seven enumerated

reasons, and also provides that "[t]he person making a request and the public body may agree in writing to extend the time for compliance for a period to be determined by the parties."

With regard to electronic copies, section 6(a) of FOIA (5 ILCS 140/6(a) (West 2016)) provides:

When a person requests a copy of a record maintained in an electronic format, the public body shall furnish it in the electronic format specified by the requester, if feasible. If it is not feasible to furnish the public records in the specified electronic format, then the public body shall furnish it in the format in which it is maintained by the public body, or in paper format at the option of the requester.

The Public Access Bureau "has previously determined that section 6(a) of FOIA does not require a public body to furnish in electronic format records maintained solely in paper format, even if the public body has resources to reproduce those records in PDF." Ill. Att'y Gen. PAC Req. Rev. Ltr. 28697, issued April 18, 2014, at 2. In addition, section 6(b) of FOIA (5 ILCS 140/6(b) (West 2016)), which concerns fees for paper copies, provides, in pertinent part:

> Except when a fee is otherwise fixed by statute, each public body may charge fees reasonably calculated to reimburse its actual cost for reproducing and certifying public records and for the use, by any person, of the equipment of the public body to copy records. No fees shall be charged for the first 50 pages of black and white, letter or legal sized copies requested by a requester. The fee for black and white, letter or legal sized copies shall not exceed 15 cents per page. If a public body provides copies in color or in a size other than letter or legal, the public body may not charge more than its actual cost for reproducing the records.

In its response to this office, the City addressed the timeliness of its response to Ms. Ajster's request by explaining that when it e-mailed Ms. Ajster on March 28, 2018, about the size of her request, Ms. Ajster expressed that she was fine with the City taking additional time to respond. This office has reviewed a copy of the e-mail exchange between the City and Ms. Ajster and confirmed that she granted the City extra time to respond. While the parties did not discuss or agree on a specific due date for the City's response, Ms. Ajster did not express that she sought any limitations to the additional time for response or otherwise indicate any objections to an extension. Consequently, this office concludes that the correspondence was sufficient to extend the City's time for compliance. *See Garlick v. Bloomingdale Twp.*, 2018 IL App (2d)

171013, ¶37, ____N.E.3d ____ (2018) (concluding that a requester's reply to a public body that an answer by a particular date "would be appreciated" was sufficient to extend the time for compliance to that date). Therefore, for purposes of assessing a copying fee, this office concludes that the City's April 16, 2018, response was timely.

Discussing its rationale for assessing Ms. Ajster a copying fee for paper copies rather than providing her with electronic copies free of charge, the City explained:

When a request of this size is received and it is determined that multiple departments and/or individuals will be providing documentation, we ask that they gather from paper files or print out related electronic files so that all information can be compiled in a central location. Based on this method it is difficult to determine which documents were copied from a paper file or printed from an electronic source. It is my belief based on communication with those that provided documentation that as much as 50% of the documents were copied from an electronic format.^[8]

The City questioned whether Ms. Ajster should be liable for half of the fee given its estimate that half of the records did not exist in an electronic format.

Because a public body is not required to provide electronic copies of records that are maintained solely in paper format, the City was not required to convert the responsive records maintained in paper format into an electronic format. As to the remaining records, section 6(a) of FOIA provides, in pertinent part, that "the public body shall furnish it in the electronic format *specified by the requester*, if feasible." (Emphasis added.) As also quoted above, the next sentence of section 6(a) again references "the *specified* electronic format." (Emphasis added.) Accordingly, section 6(a) of FOIA signifies that when a request specifies that it seeks electronic copies, the public body must provide electronic copies of records that it maintains in an electronic format, free of charge. Even if a requester specifies an electronic format and the public body does not maintain the electronic records in that format, the public body must either convert the electronic records to that format, if feasible, or provide the requester with electronic copies of the records in the electronic format in which they are maintained or paper copies at the option of the requester. Here, Ms. Ajster's request did not specify that she sought electronic copies. Although Ms. Ajster contended that the City had previously provided her with copies of records electronically, the City did not, by that course of

action, bind itself to providing all future responsive records electronically regardless of the format in which they are maintained.

The current copying fee dispute potentially could have been avoided in part if the City had provided Ms. Ajster with a fee estimate prior to beginning to make copies of the records maintained only in paper format. Nonetheless, although FOIA requires that a public body provide fee estimates for voluminous requests,⁹ it does not set forth a similar requirement for non-voluminous requests. Here, the City did not assert that the request was a voluminous request and, therefore, the City was not required to provide an estimate of the fees to be charged. See Ill. Att'y Gen. PAC Req. Rev. Ltr. 41192, issued September 8, 2017, at 4 (concluding that a public body was not required to provide an estimate of fees to be charged or provide an opportunity to narrow a request where the public body did not assert that the request was a voluminous request). Further, although Ms. Ajster alleged that the City had claimed to the News Tribune that FOIA responses are free, sections 6(a) and 6(b) of FOIA expressly permit a public body to charge for certain costs involved in reproducing records. In this case, the total cost of \$225.60 reflects a charge of 15 cents per page for the 1554 pages of documents after 50 free pages. Thus, the City's fee is permissible under section 6(b) of FOIA. Under these circumstances, this office concludes that the copying fee the City assessed did not violate FOIA. Still, because it appears that Ms. Ajster would have had the right to obtain copies of approximately half of the records free of charge if she had specified that she sought electronic copies, and because she may have reasonably believed that it was not necessary to specify that she sought electronic copies in order to receive electronic copies of the records maintained electronically in light of her previous FOIA correspondence with the City, the City's idea about halving the copying fee sounds reasonable.

Lastly, with regard to Ms. Ajster's claim that the City required her to pick up the paper copies rather than mailing them to her, it appears that the City contemplated an in-person

exchange of payment for the copies. Although a public body may require receipt of the authorized copying fee prior to providing a requester with copies of responsive records, this office has previously determined that "FOIA requires a public body to mail copies of records when the requester has provided the public body with a mailing address; the public body may not impose a fee for the cost of the regular postage." *See* III. Att'y Gen. PAC Req. Rev. Ltr. 41192, issued September 8, 2017, at 4. Here, the City did not dispute Ms. Ajster's claim or otherwise indicate that it would mail the responsive records at no additional cost. Consequently, this office reminds the City to offer requesters the opportunity to receive paper copies by regular mail once they have paid any requisite copying fees. Further, if it has not already done so, this office requests that the City mail copies of the first 50 pages of responsive documents at no cost to Ms. Ajster.

The Public Access Counselor has determined that resolution of this matter does not require the issuance of a binding opinion. This letter shall serve to close this matter. If you have any questions, please contact me at the Chicago address listed on the first page of this letter.

Dear Ms. Ajster:

This determination letter is issued pursuant to section 3.5(b) of the Open Meetings Act (OMA) (5 ILCS 120/3.5(b) (West 2016)). For the reasons set forth below, the Public Access Bureau concludes that no further action in this matter is warranted.

In your Request for Review, received January 22, 2019, you alleged that the Peru City Council (City Council) violated OMA in connection with its meeting held the previous day. Specifically, you claimed that the agenda for the meeting, which was posted more than 48 hours in advance of the meeting, listed an item for the purchase of more than 70 acres of land, yet "purchasing said property was never on any previous agenda or discussed at any City Council meeting."¹ You provided a copy of a local newspaper article in which Mayor Scott Harl explained that he had "made phone calls one-on-one with all eight aldermen" about the potential purchase; you argued that this "way of conducting City of Peru business without the need for an open meeting to discuss the matter[]" circumvents both the express requirements and intent of OMA because "when it comes time for an open meeting, all the alderman [sic] need to do is vote[.]"²

Section 3.5(a) of OMA (5 ILCS 120/3.5(a) (West 2016)) provides that "[a] person who believes that a **violation of this Act** by a public body has occurred may file a request for review with the Public Access Counselor established in the Office of the Attorney General[.] * * * The request for review * * * must include a summary of the **facts supporting the allegation**." (Emphasis added.)

Under OMA, deliberations among a majority of a quorum of the members of a nine-member public body like the City Council must be held during a properly-noticed open meeting, unless the topic of the discussion meets one of the exceptions listed in section 2(c) of OMA (5 ILCS 120/2(c) (West 2017 Supp.), as amended by Public Act 100-646, effective July 27, 2018) and the meeting is properly closed in accordance with section 2a of OMA (5 ILCS 120/2a (West 2016)). 5 ILCS 120/2(a) (West 2017 Supp.), as amended by Public Act 100-646, effective July 27, 2018. OMA generally does not govern one-on-one conversations between a mayor and an alderman. Nonetheless, it is conceivable that conversations among less than a majority of a quorum of the members of a public body could be structured in a way that would violate the spirit if not the express requirements of OMA. For instance, in Request for Review 2011 PAC 14722, this office examined circumstances in which three committee members-a majority of a quorum of the committee-attempted to avoid triggering the requirements of OMA by having one member at a time cycle in and out of a room where the other two members would deliberate. This office concluded that "this maneuvering violated the spirit and intent of OMA[,]" as "[f]inding otherwise would have [had] the absurd result of sanctioning secret deliberations and discussions of public business provided that members of a public body rotate in and out of the meeting room to avoid the simultaneous presence of a majority of a quorum." Ill. Att'y Gen. PAC Req. Rev. Ltr. 14722, issued August 12, 2011, at 5. This office also noted that the definition of "meeting" in section 1.02 of OMA (5 ILCS 120/1.02 (West 2016)) refers to "interactive communication" that is "contemporaneous" in timing rather than "simultaneous," indicating that back-and-forth communications about public business involving a majority of a quorum of the members of a public body may qualify as comprising a meeting if they occur "in the same general time frame[.]" Ill. Att'y Gen. PAC Req. Rev. Ltr. 14722, at 4-5.

In this instance, on the other hand, the information you have set forth is insufficient to support the allegation that the City Council violated the letter or spirit of OMA because there is no indication that the mayor's one-on-one conversations amounted to deliberation among a majority of a quorum of the members of the public body. According to the newspaper article, "[Mayor] Harl said the city has been discussing buying this piece of property for five to seven years[,]" and had "been keeping an eye on it[.]"³ When the price for the property dropped significantly, according to Mayor Harl, he phoned aldermen individually and received positive feedback about moving forward with the purchase. No facts have been

presented from which this office could conclude that Mayor Harl served as a sort of intermediary relaying various positions among aldermen to each other in a deliberative manner that could have risen to the level of "contemporaneous interactive communication" among a majority of a quorum of the City Council. Although you stated that you regularly attend City Council meetings and that the purchase had never been discussed during any meeting, there are multiple ways in which the City could have considered the possibility of the purchase prior to the January 21, 2019, meeting without violating OMA. For example, City staff members could have discussed the matter among themselves or with just the mayor or with the mayor and a couple of aldermen. Additionally, the City Council could have discussed the matter in closed session under the section 2(c)(5) exception to the general requirement to conduct business openly. *See* 5 ILCS 120/2(c)(5) (West 2017 Supp.), as amended by Public Act 100-646, effective July 27, 2018 (permitting a public body to discuss in closed session: "The purchase or lease of real property for the use of the public body, including meetings held for the purpose of discussing whether a particular parcel should be acquired.").

Because your Request for Review does not provide a basis from which this office could conclude that the City Council violated OMA in connection with the land purchase it approved during its January 21, 2019, meeting, the Public Access Bureau has determined that no further action is warranted in this matter.
