

Resident Marvin Gum asked about costs such as pool manager and chemicals and stated he is dead against a new pool. Mr. Deines stated approximately 20-30 hours per week at \$15.00 per hour. Mr. Gum asked if park department employee may be pool certified.

Resident Gena Martin asked if the splash pad and pool would be combined. Mr. Deines stated that answer would be within the study. Ms. Martin also stated she hopes the public will have input on pool design.

Ms. Mayszak asked about heated pool options. Mr. Deines stated most pools in Illinois are heated.

Mr. Joe Witczak asked about water lost as part of the study. Mr. Deines stated yes.
