A Committee Of A Whole meeting was called to order by Mayor Scott J. Harl in the Peru City Council Chambers on Monday, April 13, 2020 at 6:00 p.m.

City Clerk Dave Bartley called the roll with Aldermen Ferrari, Waldorf, Lukosus, Radtke, Payton present; Aldermen Sapienza, Ballard and Buffo remotely; Mayor Harl present.

PRESENTATION

MINUTES

Mayor Harl presented the Committee Of A Whole Minutes of March 16, 2020. Alderman Waldorf made a motion that the minutes be received and placed on file. Alderman Lukosus seconded the motion; motion carried.

CLOSED SESSION

Alderman Payton made a motion to go into closed session to discuss meetings where the purchase or lease of real property for the use of the public body is being considered, including meetings held for the purpose of discussion whether a particular parcel should be acquired, or where the public body is considering the setting of a price for sale or lease of its property; meetings to consider the appointment, employment, compensation, discipline, performance or dismissal of specific employees, including the public body's legal counsel, or to hear testimony on a complaint lodged against an employee to determine its validity and Collective Negotiating Matters Between Public Employers And Their Employees Or Representatives. Alderman Waldorf seconded the motion. City Clerk Dave Bartley called the roll with Aldermen Ferrari, Waldorf, Lukosus, Radtke, Sapienza, Payton, Ballard and Buffo voting aye; motion carried.
