

ORDINANCE NO.

AN ORDINANCE AUTHORIZING THE EXECUTION OF A DEVELOPMENT AGREEMENT BY AND BETWEEN THE CITY OF PERU AND JOHN POHAR AND SONS, INC. (Property South of Wenzel Road - PINs:17-09-221-000 & 17-09-234-000)

WHEREAS, the City of Peru, an Illinois home rule municipal corporation ("City"), has negotiated a certain Development Agreement dated November 22, 2021 with John Pohar and Sons, Inc. ("Pohar"), a copy of which is attached hereto and incorporated herein ("Development Agreement"), as it relates to Pohar's development of 31± acres of farmland generally located south of Wenzel Road and north of Baker Lake Park ("Subject Property"); and

WHEREAS, for the reasons stated in the Recitals of the attached Development Agreement, the Corporate Authorities of the City of Peru find and determine it is in the best interests of the City for the Subject Property to be developed as provided therein, and for the City to offer certain economic incentives to Pohar to do so.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, LASALLE COUNTY, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

<u>SECTION 1:</u> <u>**Recitals.**</u> The City Council finds as facts the recitals hereinbefore set forth.

SECTION 2: <u>Authorization.</u> The Mayor and City Clerk and each of them, for and behalf of the City, are hereby authorized and directed to execute the Development Agreement. The Mayor and City Clerk, or their designees, are further authorized and directed to perform all acts and deeds necessary to effect and fulfill the terms of the Development Agreement.

SECTION 3: Effective Date. This Ordinance shall be in full force and effect immediately from and after its passage and approval as provided by law.

DEVELOPMENT AGREEMENT

BY AND BETWEEN

THE CITY OF PERU, an Illinois home rule municipal corporation

AND

JOHN POHAR AND SONS, INC., an Illinois Corporation

November 22, 2021

This **DEVELOPMENT AGREEMENT** (this "**Agreement**") is entered into as of the 22nd day of November, 2021 (the "**Effective Date**") by and between the **CITY OF PERU**, an Illinois home rule municipal corporation ("**City**"), and **JOHN POHAR AND SONS, INC.,** an Illinois corporation ("**Pohar**""). The City and Pohar are referred to individually as a "**Party**" and collectively as the "**Parties**". The term "Pohar's Representatives" shall include Pohar's contractors, sub-contractors, agents, employees, and designees.

RECITALS

WHEREAS, the City is a home-rule municipal corporation organized and existing under the laws of the State of Illinois exercising the powers granted to it by Article VII, Section 6 of the Constitution of the State of Illinois and by the statutes and laws of the State of Illinois; and

WHEREAS, the City has the authority, pursuant to the laws of the State of Illinois, to promote the health, safety and welfare of the City and its inhabitants, to prevent the presence of blight, to encourage and expend funds to promote private development in order to enhance the local tax base and increase additional tax revenues realized by the City, to foster increased economic activity withing the City, to increase employment opportunities within the City, to enter into contractual agreements with third parties for the purpose of achieving the aforesaid purposes, and to otherwise take action in the best interests of the City; and

WHEREAS, the City is authorized under the provisions of the Illinois Municipal Code, including, but not limited to, 65 ILCS 5/8-1-2.5, to appropriate and expend funds for economic development purposes that are deemed necessary or desirable for the promotion of economic development within the City; and

WHEREAS, Pohar is an Illinois corporation with its principal place of business in LaSalle, Illinois, primarily engaged in the business of construction and excavation; and

WHEREAS, in conjunction with City's recent construction of a new police station at 2650 N. Peoria Street in Peru, City and Pohar entered into a certain Development Agreement dated July 6, 2020, whereby City provided Pohar with certain economic incentives to develop 10.783± acres of undeveloped farmland located south of the Police Station into a residential subdivision commonly known as "The Pointe", comprised of eighteen (18) affordable single-family lots surrounded by recreational paths; and

WHEREAS, the Parties are satisfied with each other's performance under the July 6, 2020 Development Agreement, and all eighteen residential lots in The Pointe Subdivision were sold within approximately one (1) year, with high-quality homes already constructed or under construction; and

WHEREAS, Pohar is or will be the sole fee simple title holder of certain real property generally located south of Wenzel Road in the City of Peru, which property is legally described and depicted on **Exhibit A** attached hereto (the "Subject Property"); and

WHEREAS, the Subject Property is comprised of $31\pm$ acres of undeveloped farmland and situated directly adjacent to City-owned property, namely Baker Lake Park to the south and a drainage ditch to the west; and

WHEREAS, Pohar has indicated an interest and desire to develop the Subject Property as a mixed-use subdivision containing fifty-seven (57) affordable single-family residential lots and three (3) commercial lots along Wenzel Road in accordance with the preliminary plans submitted to the City (the "Project"); and

WHEREAS, Baker Lake Park is a City-owned park featuring an $8\pm$ acre lake suitable for fishing, surrounded by approximately one (1) mile of recreational paths, shelters, soccer fields, playgrounds, a disc golf course and other amenities; and

WHEREAS, Baker Lake acts as a wet detention basin, receiving surface water drainage from large commercial developments in north Peru through the drainage ditch located along the west boundary of the Subject Property; and

WHEREAS, the aforementioned drainage ditch is unimproved and natural in character, having been unaltered since Baker Lake was developed nearly 40 years ago; and

WHEREAS, over the last 40 years, a substantial amount of silt and sediment has been carried down the unimproved drainage ditch and deposited into Baker Lake, considerably reducing its depth, causing areas of the lake to become stagnant marshland attracting mosquitos and other undesirable pests, and negatively impacting fishing activities and the overall beauty of the park ("Silt & Sediment Issue"); and

WHEREAS, the Corporate Authorities of the City have an interest in improving the drainage ditch including, but not limited to, the construction of check dams, to capture and allow for the easy removal of silt and sediment before it enters Baker Lake, to correct the cause of the Silt & Sediment Issue before performing dredging of the lake; and

WHEREAS, the Corporate Authorities of the City have an interest in expanding the recreational path at Baker Lake Park and throughout the City of Peru to create pedestrian linkages which reduce traffic congestion and reliance on automobiles, promote walkability and healthy lifestyles, and improve quality of life ("Recreation Improvements"); and

WHEREAS, the Corporate Authorities of the City acknowledge the limited availability of affordable lots for residential development within the City of Peru, as recently evidenced by the demand and success at The Pointe Subdivision, and have an interest in increasing the supply of such lots in order to enhance the local tax base and tax revenues realized by the City, foster local economic activity, increase employment opportunities, promote growth of the City, and overall make the City and surrounding areas a more desirable place to live and raise families; and

WHEREAS, jurisdiction of Wenzel Road, also known as 24th Street in LaSalle, in the vicinity of the Subject Property is split between City and the neighboring City of LaSalle; and

WHEREAS, the City intends to enter into an Intergovernmental Agreement with the City of LaSalle to improve Wenzel Road/24th Street during the 2022 construction season; and

WHEREAS, the City owns and maintains an underground water main on the north side of the Subject Property that runs east under Wenzel Road, then south on Airport Road to Gunia Drive in Peru; and

WHEREAS, a significant portion of the aforementioned watermain is now located within the jurisdiction of the City of LaSalle and does not, and will not, serve City residents; and

WHEREAS, the watermain is at the end of its useful life, necessitating regular costly repairs, and is in need of replacement at great expense to the City ("Watermain Issue"); and

WHEREAS, the Corporate Authorities of the City have an interest in resolving the Watermain Issue by constructing a new watermain extending northwest through the Subject Property from the west end of Gunia Drive to Wenzel Road, which will realize significant cost savings over replacing the existing watermain under Wenzel Road, and eliminate nearly 1000' of excess watermain and associated maintenance costs, while preserving the existing system loop; and

WHEREAS, the Project contemplates a land swap between the Parties, with City conveying to Pohar a portion of the real estate described and depicted in <u>Exhibit B</u> attached hereto, and Pohar conveying to City "Outlot 1", dedicating to City all public streets, and granting to City all rights-of-way and easements described and depicted on the Plat of Subdivision attached hereto as <u>Exhibit C</u>; and

WHEREAS, the Corporate Authorities of the City find and determine the real estate described and depicted in **Exhibit B** to be conveyed to Pohar pursuant to this Agreement, is no longer necessary, appropriate, required for the use of, profitable to, or for the best interest of the City; and

WHEREAS, the Corporate Authorities of the City deem it to be in the best interest of the City for the Subject Property to be developed in the manner intended by Pohar provided the Project addresses the Baker Lake Silt and Sediment Issue, the Watermain Issue, and provides for certain Recreation Improvements as described further herein; and for the City to offer certain economic incentives to Pohar to do so; and

WHEREAS, the City Council has made the following findings with respect to this Agreement and the economic incentives offered to Pohar: (1) that the Subject Property is undeveloped; (2) that the Project will increase the availability of affordable residential lots for development, enhance the local tax base and tax revenues realized by the City, foster local economic activity, increase employment opportunities, and promote growth of the City of Peru; (3) that the Project will serve to beautify Baker Lake Park, the drainage ditch, and surrounding area by, among other things, resolving the Silt and Sediment Issue; (4) that the Project will expand recreational opportunities and pedestrian linkages in the City, promoting walkability and quality of life; (5) that the Project will address the Watermain Issue and result in significant cost savings to the City; (6) that the City has excess asphalt grindings it can provide to Pohar to be utilized as

a road base for the Project to reduce Project costs; (7) that the City can further reduce the Project costs by providing Pohar assistance with engineering, platting and permitting needs; (8) that Pohar has demonstrated its ability to complete the Project, and meets a high standard of creditworthiness and financial strength; (9) that the Project will strengthen the commercial sector of the City; (10) that without the economic incentives offered to Pohar, the Project would not be possible; and (11) that this Agreement is made in the best interest of the City; and

WHEREAS, the Parties have entered into this Agreement for the purposes of memorializing the agreements reached with respect to Pohar's development of the Subject Property and the economic incentives to be offered by the City to Pohar for the Project.

NOW, THEREFORE, in consideration of the foregoing recitals, the covenants and agreements hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

SECTION 1 RECITALS

The recitals set forth above are accurate and are expressly incorporated into this Agreement by this reference thereto as if fully set forth in this Section 1.

SECTION 2 AUTHORITY

This Agreement is entered into by the City pursuant to applicable law, including provisions of the Illinois Constitution of 1970 and 65 ILCS 5/8-1-2.5.

<u>SECTION 3</u> DEVELOPMENT OF THE SUBJECT PROPERTY; ECONOMIC INCENTIVES

(A) <u>**Purchase of the Subject Property.</u>** Pohar has, or will, purchase the Subject Property at its own cost and expense.</u>

(B) Land Swap.

- (1) <u>City to Pohar</u>. City agrees to execute a deed conveying title of certain City-owned real estate to Pohar, said real estate being described and depicted on <u>Exhibit B</u> attached hereto, which will then become part of the Subject Property.
- (2) <u>Pohar to City.</u> In exchange for the City's conveyance of the real estate described and depicted on <u>Exhibit B</u>, Pohar agrees to dedicate to City all public streets, including the mailbox turnout area, and grant to City all public rights-of-way and easements, all of which being described and depicted on the Plat of Subdivision attached hereto as <u>Exhibit C</u>. Pohar further agrees to dedicate a portion of the Subject Property, identified as "Outlot 1" on <u>Exhibit C</u>, to City for public use as a public park. As part of the Project, Pohar shall grade, prepare, and develop Outlot

1 at Pohar's sole cost for future use as a City park in accordance with plans and specifications as agreed upon by the Parties.

(3) City shall be solely responsible for payment of all engineering, legal, and recording costs and expenses related to the land swap described herein.

(C) <u>Plat of Subdivision.</u> The Parties will cooperate in the preparation of a Plat of Subdivision for the Subject Property. Such plat shall provide for fifty-seven (57) residential lots, three (3) commercial lots, and shall identify the location of all public roadways, rights-of-way and easements to be dedicated or granted by Pohar to the City. A copy of the final Plat of Subdivision shall be attached hereto as <u>Exhibit C.</u> Pohar shall include any and all required rezoning and variance requests as part of Pohar's Petition for approval of the Final Plat of Subdivision, which shall be subject to approval by the City Council.

(D) <u>Project Infrastructure Improvements.</u> The Parties understand and agree that it is necessary for certain infrastructure improvements to be constructed in connection with the Project. Unless explicitly provided elsewhere in this Agreement, Pohar, at Pohar's sole cost and expense, shall be responsible for complete construction of all Project: mass and fine grading; electric, water, sanitary/storm sewer utilities; concrete curb, gutter, and sidewalks; recreational paths, and Project landscaping.

(E) <u>Construction of Project Roadways</u>. In connection with the Project, the Parties understand and agree that it will be necessary to designate and construct public roads to provide access to and throughout the Subject Property subdivision. As an economic incentive for Pohar's undertakings under this Agreement, the Parties agree as follows:

- (1) <u>Aggregate Base Course Material</u>. At City's cost and expense, City shall provide Pohar with suitable aggregate material required to construct the base course for the Project's public roads as depicted on <u>Exhibit C</u>. The Parties shall coordinate City's delivery of the aggregate base course material to the Subject Property, which shall occur no later than the end of City's 2023 fiscal year.
- (2) <u>Hot-Mix Asphalt Binder Course.</u> At City's cost and expense, City shall place the hot-mix asphalt binder course upon the Project's public roads as depicted on <u>Exhibit C</u>. The expense for placement of the hot-mix asphalt binder course shall be included as part of City's 2023 General Fund Street Program. The Parties shall coordinate City's placement of the hot-mix asphalt binder course upon the Subject Property, which shall occur no later than the end of City's 2024 fiscal year.
- (3) <u>Hot-Mix Asphalt Surface Course.</u> At City's cost and expense, City shall place the hot-mix asphalt surface course upon the Project's public roads as depicted on <u>Exhibit C</u>. The expense for placement of the hot-mix asphalt surface course shall be included as part of City's General Fund Street Program. The Parties shall coordinate City's placement of the hot-mix asphalt surface course upon the Subject Property, which shall occur no later than the end of City's 2027 fiscal year.

(F) **<u>Project Utility Improvements</u>**. The Parties understand and agree that it is necessary for certain utility improvements to be constructed in connection with the Project. As an economic incentive for Pohar's undertakings under this Agreement, the Parties agree as follows:

- (1) <u>Watermain Improvements</u>. City shall provide Pohar with a Four Hundred Fifty Thousand Dollar (\$450,000.00) Utility Fund incentive to be allocated towards the Project's watermain construction. The Parties understand and agree this incentive is for the purpose of re-routing the City's watermain through the Subject Property, as depicted on <u>Exhibit C</u>, to address the Watermain Issue. Pohar and/or the future owner of any Lot shall be responsible for all costs and expenses related to construction of service lines and tapping on to the City's watermain. City shall pay this incentive to Pohar from the City's Utility Fund during City's 2023 Fiscal Year.
- (2) <u>Sanitary Sewer Improvements</u>. City shall provide Pohar with a Five Hundred Thousand Dollar (\$500,000.00) Utility Fund incentive to be allocated towards the Project's sanitary sewer construction. Pohar and/or the future owner of any lot shall be responsible for all costs and expenses related to construction of service lines and tapping on to the City's sanitary sewer. City shall pay this incentive to Pohar from the City's Utility Fund during City's 2023 Fiscal Year.

(G) <u>**Project Recreation Improvements.**</u> In exchange for City's economic incentives provided herein, Pohar agrees to complete the following Recreation Improvements as part of the Project in accordance with plans and specifications agreed upon by the Parties:

- (1) <u>Drainage Ditch Improvements</u>. At Pohar's sole cost and expense, Pohar shall realign, reshape, regrade, and clean the existing drainage ditch located west of the Subject Property, from Wenzel Road to Baker Lake. Pohar shall also construct a series of "check dams" along the ditch to capture and allow for the easy removal of silt and sediment before it enters Baker Lake.
- (2) <u>Recreational Path Construction.</u> At Pohar's sole cost and expense, Pohar shall grade and construct a ten foot (10') wide concrete recreational path along the east side of the drainage ditch, as depicted on <u>Exhibit C</u>, connecting the sidewalk along Wenzel Road to the Baker Lake recreational path.
- (3) <u>Outlot 1 Improvements.</u> At Pohar's sole cost and expense, Pohar shall grade, prepare, and develop Outlot 1 for future use as a City park. Pohar shall dedicate Outlot 1 to City.

(H) <u>**Project Curbs, Gutters, and Sidewalks.</u>** Subject to the provisions below, Pohar shall construct all Project concrete curbs, gutters, and sidewalks upon the Subject Property in accordance with City's Code of Ordinances and plans approved by the City Engineer.</u>

- (1) <u>Project Critical Sidewalks</u>. Pohar shall construct the Project's "Critical Sidewalks" identified in <u>Exhibit D</u> no later than December 1, 2022.
- (2) <u>Other Project Sidewalks</u>. The other Project sidewalks identified in <u>Exhibit C</u>, which are not Critical Sidewalks, shall be constructed by the future owner(s) of

each respective Lot. All such sidewalks shall be constructed by the Lot owner(s) before an occupancy permit for the home or business in granted. Notwithstanding the foregoing, Pohar shall construct all unconstructed Project sidewalks shown on **Exhibit C**, except for those sidewalks upon the Subdivision's Commercial Lots along Wenzel Road, on or before October 1, 2028.

(I) **<u>Project Landscaping.</u>** Pohar shall submit a landscaping plan for the Project to the City for City's review and approval. Pohar shall be responsible for all Project landscaping in material conformance with the landscaping plan approved by the City.

(J) **<u>Project Engineering, Platting, and Permitting</u>**. As an economic incentive for Pohar's under this Agreement, City agrees to provide Pohar with Project engineering, platting, and permitting assistance.

(K) Development & Sale of Residential Lots.

- (1) <u>Residential Development</u>. Pohar shall develop a portion of the Subject Property into a residential subdivision containing fifty-seven (57) individual single-family residential lots.
- (2) <u>Affordable Housing</u>. The Parties understand and agree that the intent of this Agreement is, in part, to provide for the creation of affordable single-family residential lots. Accordingly, the Parties agree that, as part of the Project, certain Residential Lots shall immediately be offered for sale to the public by Pohar for no more than the Maximum Initial Sale Price assigned to that Lot provided on <u>Exhibit</u> <u>E</u>. Starting January 1, 2024, and on January 1st of each year thereafter until 2028, the Maximum Sale Price for a Lot shall increase by no more than three & one-half percent (3½ %) annually. Beginning January 1, 2028, there shall be no Maximum Sale Price imposed upon any unsold Lot still owned by Pohar, and Pohar may sell such Lot(s) at market rate. Notwithstanding the foregoing, Pohar may sell any Residential Lots, at any time for any price Pohar determines to be market rate or in the best interest of the Project.
- (3) <u>Central Mailbox Turnout.</u> The Parties understand and agree the Project will require the development and construction of a centralized mailbox turnout for use by all Residential Lot owners. Pohar shall be responsible for constructing the mailbox turnout at the location shown on <u>Exhibit C</u> at Pohar's sole cost and expense. Pohar shall dedicate the Central Mailbox Turnout to City, and City shall assume maintenance responsibilities thereafter.

(L) Development & Sale of Commercial Lots.

 <u>Development & Sale.</u> As part of the Project, Pohar shall develop three (3) Commercial Lots adjacent to Wenzel Road as shown on <u>Exhibit C</u>. There shall be no Maximum Sale Price imposed upon Pohar for the sale of these Commercial Lots. (2) <u>Business Development District.</u> In exchange for City's economic incentives provided herein, Pohar agrees to City's creation of a Business Development District ("BDD") that includes Commercial Lots 1, 2 and 3 and implements an additional one percent (1%) sales tax in the BDD. The Parties agree City may implement the BDD at such time City deems necessary or desirable, and that the BDD sales tax increment shall be pledged solely to City for the life of the BDD unless otherwise agreed to by City. This provision shall run with the land and be binding upon the future owners of each Commercial Lot.

(M) <u>Subdivision Covenants, Conditions and Restrictions.</u> Pohar shall develop and establish Subdivision Covenants, Conditions and Restrictions applicable to the residential portion of the Subject Property. The Subdivision Covenants, Conditions and Restrictions shall be subject to City's final approval and recorded with the LaSalle County Recorder's Office.

(N) **Inspections of the Subject Property.** Pohar agrees that the City may conduct unannounced inspections of the Subject Property and that Pohar shall provide the City and its agents and/or employees access to the Subject Property at all times requested by the City.

(O) <u>Prevailing Wage Rate Act</u>. Pohar shall comply with the provisions of the Illinois Prevailing Wage Act, 820 ILCS 130/0.01 *et seq.*, with respect to all work performed by Pohar and Pohar's Representatives in connection with the Project.

(P) **<u>Project Schedule.</u>** The Parties agree that the Project shall follow the following construction schedule on or before:

Spring 2022	Engineering and permitting.
Summer 2022	Begin construction.
Fall 2022	City's delivery of Project roadway base course material.
Fall 2022	Lots available for construction.
October 1, 2028	Pohar to complete construction of remaining Project sidewalks

SECTION 4 MUTUAL ASSISTANCE

The Parties agree to do all things necessary or appropriate to carry out, and to aid and assist each other in carrying out, the terms of this Agreement and in implementing the Parties' intent, as reflected by the terms of this Agreement.

SUCCESSORS AND ASSIGNS

This Agreement shall run with the land and be binding upon and inure to the benefit of the Parties' respective heirs, successors and assigns and the successor owners of record of all and any portion of the Subject Property.

SECTION 6 WAIVER AND NOTICES

A waiver of any part of this Agreement shall be limited to that specific event, shall only be effective if made in writing, and shall not be a waiver of the entire Agreement. Any notices required in this Agreement shall be effective when received in writing by the other Party via overnight mail, certified mail return receipt requested, or by delivering the same in person or by facsimile, when appropriate, addressed to the Party to be notified.

SECTION 7 DEFAULT AND ATTORNEYS' FEES; NO WAIVER; REMEDIES

(A) <u>Default and Attorneys' Fees.</u> The City and Pohar covenant and agree that in the event of default of any of the terms, provisions or conditions of the Agreement by any Party, which default exists uncorrected for a period of thirty (30) days after written notice to any Party to such

default, the Party seeking to enforce said provision may institute such proceedings as may be necessary or desirable in its opinion to cure or remedy such default or breach, including, but not limited to: actual damages and specific performance. If attorneys' fees or other costs are incurred to secure performance of any obligation under this Agreement, to establish damages for the breach thereof or to obtain any other appropriate relief, whether by way of prosecution or defense, the prevailing Party will be entitled to recover reasonable attorneys' fees and costs incurred in connection therewith.

(B) <u>No Waiver by Delay or Otherwise.</u> Unless barred by the applicable statute of limitations, any delay by either Party in instituting or prosecuting any actions or proceedings or otherwise asserting its rights under this Agreement shall not operate to act as a waiver of such rights or to deprive it of or limit such rights in any way (it being the intent of this provision that neither Party should be deprived of or limited in the exercise of the remedies provided in this Agreement because of concepts of waiver, laches or otherwise); nor shall any waiver in fact made with respect to any default of this Agreement be considered or treated as a waiver of the rights by the waiving Party of any future default of this Agreement hereunder, except to the extent specifically waived in writing. No waiver made with respect to the performance, nor the manner or time thereof, of any obligation or any condition under the Agreement shall be considered a waiver of any rights except if expressly waived in writing.

(C) <u>Rights and Remedies Cumulative.</u> The rights and remedies of the Parties to this Agreement, whether provided by law or by this Agreement, shall be cumulative, and the exercise of any one or more of such remedies shall not preclude the exercise by such Party, at that time or different times, of any other such remedies.

SECTION 8 COMPLIANCE WITH APPLICABLE LAWS; NONDISCRIMINATION

Pohar shall comply with all applicable local, state and federal laws with respect to any action taken in the performance of this Agreement, including the sale of Lots, and shall not engage in discrimination on the basis of race, color, religion, gender, national origin, disability, or any other basis prohibited by law.

SECTION 9 INDEMNIFICATION

Pohar agrees to indemnify, defend and hold harmless the City, its Mayor, Aldermen, officials, officers, employees, agents and representatives ("Indemnified Parties"), from and against all claims, causes of action and suits of every kind and nature, including, by way of example and not by way of limitation, liabilities, damages, costs, expenses and reasonable attorneys' fees arising by reason of Pohar's actions under this Agreement, the failure by Pohar to perform any of its obligations provided for herein, any claim for personal injury or property damage arising by reason of construction activity on the Subject Property, and any other claim of any nature whatsoever related to establishment, financing or construction of the Project other than claims caused by or arising by reason of an Indemnified Party's breach of this Agreement, gross negligence or willful misconduct. Any claim against the City pursuant to this Section shall be defended by counsel approved by the City (which approval shall not be unreasonably withheld) or counsel appointed by Pohar's insurer if such claim is covered by Pohar's insurance.

SECTION 10 MISCELLANEOUS

(A) <u>Integration</u>. This Agreement and exhibits attached hereto, contains the entire agreement of the Parties with respect to the transactions contemplated by this Agreement. All prior agreements, negotiations, and understandings are expressly merged herein and superseded hereby. All exhibits to this Agreement are expressly incorporated herein by this reference thereto.

(B) <u>Severability</u>. Each section of this Agreement, and each sentence, clause or phrase contained in such section, shall be considered severable and if, for any reason, any section, or any sentence, clause or phrase contained in such section, is determined to be invalid or unenforceable, such invalidity or unenforceability shall not impair the operation, effect enforceability or validity of the remaining portions of this Agreement.

(C) <u>Amendment</u>. This Agreement may be amended by, and only by, a written instrument signed by the Parties.

(D) <u>Headings</u>. Section or other headings contained in this Agreement are for reference purposes only and shall not affect in any way the meaning or interpretation of this Agreement.

(E) <u>Time is of the Essence</u>. Time is of the essence of this Agreement and of each and every provision hereof.

(F) <u>Counterparts</u>. This Agreement may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same agreement.

(G) <u>Exhibits</u>. The exhibits attached to this Agreement are hereby incorporated into and made a part of this Agreement.

(H) <u>Applicable Law and Venue</u>. This Agreement shall be governed by and construed under the laws of the State of Illinois. Venue shall be proper only in the Circuit Court of LaSalle County, Illinois which shall be the only appropriate forum for the resolution of disputes hereunder.

(I) <u>Force Majeure</u>. Neither City, nor any successors in interest, shall be considered in breach of or in default of its obligations under this Agreement in the event of any delay caused by damage or destruction by fire or other casualty, strike, shortage of material, unusually adverse weather conditions, including but not limited to, severe rain storms or below freezing temperatures of abnormal degree or for an abnormal duration, tornadoes or cyclones, acts of terrorism and other events or conditions beyond the reasonable control of City which in fact delay City in discharging its obligations hereunder. For purposes of this Agreement, "terrorism" is defined as an activity that (i) involves the use or threat of force or violence, the commission or threat of an act dangerous to human life, property or infrastructure, or the commission or threat of an act that interferes with or disrupts an electronic communication, information or mechanical system, and (ii) has the effect of or appears to be intended to intimidate or coerce a civilian population, to influence the policy of a government by intimidation or coercion, to affect the conduct of a government by mass destruction, assassination, kidnapping, or hostage-taking, or to disrupt any segment of the economy.

(J) Recordation of Agreement. The Parties agree to record this Agreement with the LaSalle County Recorder's Office upon its execution, with City paying the costs associated with such recording.





EXHIBIT C Final Plat of _____ Subdivision to the City of Peru, Illinois (*Concept, to be updated*)




