CITY OF PERU REGULAR COUNCIL MEETING APRIL 10, 2023

A regular meeting of the Peru City Council was called to order by Mayor Ken Kolowski in the Peru City Council Chambers on Monday, April 10, 2023, at 7:05 p.m.

City Clerk Dave Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus, and Buffo present; Mayor Kolowski present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

PUBLIC COMMENT

PRESENTATION/PROCLAMATION

On March 11, 2023, at approximately 6:57pm, an ambulance was dispatched to a residence for the report of a female breathing but not conscious. The female's status quickly changed to not breathing, and CPR would be needed. Officers arrived on scene less than 2 minutes following the 911 call. It was another 8 minutes before the LaSalle Ambulance service arrived on scene as the Peru Ambulance service was unavailable.

In that time, Officer William Sommer and Officer Hunter Wright, assessed the patient and provided lifesaving care. They quickly ascertained the patient had agonal breathing, no pulse, and was turning blue. Together they administered 3 separate doses of Narcan, began and continued CPR, and attached the AED. Fire Captain Bill Krolak arrived to assist officers, placing an oral airway into the patient. Shortly after the 3rd dose of Narcan and upon placement of the oral airway, the patient took a deep breath and started coughing. She was sitting up on her own, awake, and breathing upon arrival of the LaSalle Ambulance service.

Without the quick response, professional training, and caring and compassion for the patient by these officers, the outcome may have been very different. Because of the efforts of these officers, the patient is home and recovering with her family. The quality-of-care Officer Sommer and Officer Wright provided, shows their first responder training, knowledge, and certification is an integral part of the community-based policing service we provide. Without the first responder program and the quick and willing response of not only these officers, but all Peru Police officers, more outcomes in incidents such as this would be fatal. These officers deserve to be recognized for their efforts, as they saved a human life.

Illinois Valley Regional Dispatch Board Director Brandon Miller presented a proclamation proclaiming April 9-15, 2023 as National Public Safety Telecommunicators Week. Alderman Buffo made a motion the proclamation be received and placed on file. Alderman Edgcomb seconded the motion; motion carried.

Alderman Buffo made a motion the disbursements be received, placed on file and the bills be paid in the usual manner. Alderman Tieman seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus and Buffo voting aye; motion carried.

Alderman Payton made a motion to approve \$235,000 reinvestment into Parkway Bank & Trust, CD at 5.1% for 12 months. Alderman Tieman seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus and Buffo voting aye; motion carried.

PUBLIC SERVICES COMMITTEE

Alderman Lukosus made a motion to approve the 2023 MFT Program to Universal Asphalt & Excavating in the amount of \$235,133.22. Alderman Ballard seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus and Buffo voting aye; motion carried.

Alderman Lukosus made a motion to authorize the Mayor and City Clerk to execute the Joint Funding Agreement for the Safe Routes to School project (Section # 22-00071-00-SW) extending sidewalk along Shooting Park Road. Alderman Buffo seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus and Buffo voting aye; motion carried.

POLICE AND FIRE COMMITTEE

Alderman Buffo made a motion to approve purchase of body worn cameras and 2 in car camera systems from Motorola Solutions with the first-year installment price of \$23,050. The following 4 years will each have a price of \$15,830 for a total at the end of the 5-year period of \$86,370 (less an expected \$800 per body worn camera reimbursement through grant money). Alderman Tieman seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Waldorf, Sapienza, Lukosus and Buffo voting aye; motion carried.
