A regular meeting of the Peru City Council was called to order by Mayor Ken Kolowski in the Peru City Council Chambers on Monday, November 6, 2023, at 7:06 p.m.

City Clerk Dave Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno present; Mayor Kolowski present.

PUBLIC COMMENT

PRESENTATION

MINUTES/FINANCIAL REPORTS/ACTIVITY REPORTS

Mayor Kolowski presented the Regular Minutes of October 23, 2023. Alderman Payton made a motion the minutes be received and placed on file. Alderman Tieman seconded the motion; motion carried.

FINANCE AND SAFETY COMMITTEE

Alderman Sapienza presented the following disbursements for payment on November 8, 2023:

Alderman Sapienza made a motion the disbursements be received, placed on file and the bills be paid in the usual manner. Alderman Tieman seconded the motion. Clerk Bartley called the roll with Alderman Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

PUBLIC SERVICES COMMITTEE

Alderman Edgcomb made a motion to approve a MOU by and between the City of Peru and the Illinois Fraternal Order of Police Labor Council Lodge 137 relating to lateral entry. Alderman Tieman seconded the motion. Clerk Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

Alderman Tieman made a motion to authorize the City of Peru Board of Fire and Police Commissioners to hire a new police officer to fill the position of School Resource Officer (lateral entry) Alderman Payton seconded the motion. Clerk Bartley called the roll with Alderman Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

Alderman O'Sadnick made a motion to authorize the City of Peru Board of Fire and Police Commissioners to seek lateral entry applications for an anticipated vacancy and/or future vacancies in the Police Department. Alderman Edgcomb seconded the motion. Clerk Bartley called the roll with Alderman Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

Police Chief Sarah Raymond initiated a discussion regarding the implementation of the Internet Safe Exchange Location at the Peru Police Department. Chief Raymond stated there has been an increase in calls for people who are buying things off the internet and safety concerns about meeting people they don't know. Chief Raymond noted the exchange zones were implemented to provide a neutral, monitored meeting place to conduct face-to-face transactions; encourages residents to utilize the police station to safely complete transactions. Chief Raymond stated she hopes the program will be a deterrent to criminals looking to take advantage of an unsuspecting victim. Chief Raymond stated residents will be able to conduct their transactions in one of two locations at the police department at 2650 N. Peoria Street (lobby and parking lot). Chief Raymond stated the lobby will be open from 8 a.m. to 4 p.m. Monday through Friday and the parking lot will have two designated "Internet Purchase Exchange Locations" parking spaces on the east side of the building. Chief Raymond stated the area is recorded by cameras 24 hours a day and is a short distance to an emergency phone connected to a 24-hour dispatch center. Chief Raymond also reported there will be a metal sign in front of the two parking stalls at the police station. Chief Raymond stated the location would be open for anyone to use and an appointment is not necessary.

Alderman Sapienza stated he knows people who sold or bought items online and go to public places to make their exchange and thinks it is a very good thing to do.

Alderman Tieman agreed and stated his business has utilized the La Salle police a couple of times to come and monitor transactions. Alderman Tieman stated it is an excellent idea, being able to do this at our police station. Alderman Tieman stated he thinks it is an asset for not just Peru, but any community members that need it.

Chief Raymond stated the police department will be open for them to come in and while our telecommunicator will be sitting there. Chief Raymond stated the program will not be manned unless there is an issue, otherwise none of the police will come out or do anything. Chief Raymond stated it will just be a safe place for them to be able to do their transactions.

Alderman Payton made a motion to approve quote from Musco Sports Lighting in the amount of \$99,800 for Sunset Park lighting improvements. Alderman O'Sadnick seconded the motion. Reported 75% of the cost will be funded by an IMEA grant. Clerk Bartley called the roll with Alderman Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

Clerk Bartley called the roll with Alderman Ballard, Tieman, Payton, Edgcomb, Sapienza, O'Sadnick, Lukosus and Moreno voting aye; motion carried.

NEW BUSINESS

Alderman Payton made a motion to authorize the Mayor to execute Letter of Commitment for the North Central Illinois Council of Governments US EPA Brownfields Coalition Assessment Grant Application. Alderman Sapienza seconded the motion. Corporate Counsel Scott Schweickert reported the grant will help the city identify any impediments to future development on select properties and believes it would be money well spent. Corporate Counsel Scott Schweickert stated the city would be partnering with Marseilles, Mendota and Streator to seek up to \$1.5 million in grant funding further noting the city's share of the application fee is \$1,625. Corporate Counsel stated we've been looking at several areas of the city, including along the waterfronts and the location of the burnt-out portion of Westclox. Mayor Kolowski asked the if there were any questions or discussion to be had about the project, noting that it seemed like a reasonable investment. Alderman Payton stated he was all for city taking advantage of receiving a potential grant.

PSM/Fire Chief Jeff King reported on emergency NIMS training and will organize training for NIMS along with tornado scenario training.

At Mayor Kolowski's request, PSM/Fire Chief Jeff King explained the MABAS model. PSM/Fire Chief King noted it is a mutual aid service agreement when there is an emergency and we send mutual help to our neighboring member communities when in need and the send help to us when we are in need.

PETITIONS AND COMMUNICATIONS

Clerk Bartley presented a communication from the City of Peru for annexation and zoning of territory located north of Shooting Park Road and west of the Peru City Cemetery. Alderman Lukosus made a motion the communication be received, placed on file and referred to the Planning/Zoning Commission for review and recommendation. Alderman Moreno seconded the motion; motion carried.

The Peru Volunteer Ambulance Service responded to two hundred thirty-eight (238) patient/calls during the month of October. The two hundred thirty-eight (238) patient/calls included one hundred seventy-nine (179) emergencies for Peru, nine (9) emergencies for Dimmick, zero (0) emergencies for Peru Township, and thirty-four (34) transfers. Of the one hundred eighty-eight (188) emergencies, one hundred thirteen (113) patients were transported, sixty-four (64) patients refused treatment, two (2) standby requests, and five (5) were disregarded.

Peru Volunteer Ambulance Service, Inc. responded to nine (9) Mutual Aid requests with La Salle Fire/EMS, four (4) Mutual Aid requests with 10/33 Ambulance, two (2) Mutual Aid requests with Oglesby Ambulance, and one (1) Motor Cross Standby requests.

The total mileage logged was 8121 miles for the month of October.

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES FOR THE CITY OF PERU, ILLINOIS, FOR FISCAL YEAR 2024 BEGINNING ON MAY 1, 2023, AND ENDING APRIL 30, 2024, BOTH INCLUSIVE.

WHEREAS, on May 8, 2023, the City Council of the City of Peru, Illinois ("City") duly passed and adopted Ordinance No. 6755, which Ordinance approved the City's annual budget for fiscal year 2024 beginning May 1, 2023, and ending April 30, 2024, both inclusive, a copy of which budgeted appropriations is attached hereto and incorporated herein; and

WHEREAS, of said total so budgeted, the City requires to be raised by real estate taxation for said fiscal year, after making allowance for estimated receipts from other sources, the sum of \$944,361.00.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, COUNTIES OF LASALLE AND BUREAU, STATE OF ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: The total amount of budgeted appropriations for corporate purposes legally made to be collected from the real estate tax levy for the current fiscal year is hereby ascertained to be the sum of \$944,361.00.

SECTION 2: The sum of \$944,361.00, being the total budget heretofore legally made which are to be collected from the real estate tax levy for the current fiscal year of the City of Peru, Illinois, for corporate purposes for said City, as appropriated for the current fiscal year by the Ordinance Approving the City of Peru's Annual Budget for Fiscal Year 2024 duly passed and adopted by the City Council at the legally convened meeting of May 8, 2023, shall be, and the same is hereby, levied upon all of the taxable property in the City of Peru, Illinois. Subject to taxation for the current year, the specific amounts as levied for the various purposes are as set forth in "Exhibit A" attached hereto.

SECTION 3: Any and all amounts which were heretofore levied for purposes set forth in any and all tax levy ordinances heretofore passed by the City Council of the City of Peru, Illinois, and which amounts were collected for such respective purposes and not expended for such purposes and which may be on hand at the commencement of this fiscal year, shall be and are hereby transferred to, and shall become a part of, the General Fund of the City of Peru, Illinois, and the same are hereby budgeted and appropriated to be used for general corporate purposes.

SECTION 4: The total amount of \$944,361.00, as ascertained as aforesaid, shall be, and the same is hereby, levied and assessed on all property subject to taxation within the City of Peru, Illinois, according to the value of said property as the same is assessed and equalized for state and county purposes for the current year.

SECTION 5: This Tax Levy Ordinance is adopted pursuant to the procedures as set forth in the Illinois Municipal Code, provided, however, any tax rate limitation or other substantive limitations as to tax levied in the Illinois Municipal Code in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Section 6, Article VII of the Constitution of the State of Illinois.

SECTION 6: There is hereby certified to the County Clerks of LaSalle County and Bureau County, Illinois, the several sums herein set forth, constituting the said total amount of \$944,361.00, which amount the City of Peru requires to be raised by taxation for the current fiscal year of the City, and the City Clerk is hereby ordered and directed to file with the County Clerks of LaSalle and Bureau Counties, Illinois, on or before the time required by law, a certified copy of this Ordinance.

SECTION 7: Should any section or provision of this Ordinance be declared invalid or unconstitutional, or in conflict with any other Section of this Ordinance, such invalidity shall not affect any other Section or provision of this Ordinance, and the same shall continue in full force and effect.

SECTION 8: All Ordinances and parts of Ordinances or amendments thereof, which are in conflict herewith, are hereby repealed.

SECTION 9: This Ordinance shall be in full force and effect immediately from and after its passage and approval and shall be published in pamphlet form.

AN ORDINANCE ABATING 2023 TAX LEVY AS PROVIDED BY BOND ORDINANCE NO. 6656 ENTITLED: "AN ORDINANCE OF THE CITY OF PERU, LASALLE AND BUREAU COUNTIES, PROVIDING THE ISSUANCE OF GENERAL OBLIGATION BONDS, SERIES 2022" DULY PASSED AND ADOPTED MAY 9, 2022.

AN ORDINANCE AUTHORIZING EXECUTION OF A MANAGEMENT AND SUPERVISION AGREEMENT FOR OPERATION OF THE WATER AND WASTEWATER TREATMENT PLANTS OF THE CITY OF PERU WITH TOTAL ENVIRONMENTAL SERVICE TECHNOLOGIES, INC.

WHEREAS, the City of Peru, Illinois (hereinafter, "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City's existing management and supervision agreement with Total Environmental Service Technologies, Inc. for operation of the City's water and wastewater treatment plants ends December 31, 2023; and

WHEREAS, the Corporate Authorities of the City desire to renew its agreement with Total Environmental Service Technologies, Inc. for another 5 year term beginning January 1, 2024, and ending December 31, 2028.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: The City Council finds as fact the recitals contained in the preamble to this Ordinance, and hereby incorporates them herein by reference.

SECTION 2: The Mayor, for and on behalf of the City, is hereby authorized and directed to execute, and the City Clerk, for and on behalf of the City, is hereby authorized and directed to attest, to the "MANAGEMENT AND SUPERVISION AGREEMENT FOR OPERATION OF THE WATER AND WASTEWATER TREATMENT PLANTS OF THE CITY OF PERU" dated November 20, 2023, by and between the City of Peru, Illinois, and Total Environmental Service Technologies, Inc., an Illinois corporation, a copy of which is attached hereto.

SECTION 3: This Ordinance shall be effective immediately from and after its passage and approval according to law. MANAGEMENT AND SUPERVISION AGREEMENT FOR OPERATION OF THE WATER AND WASTEWATER TREATMENT PLANTS OF THE CITY OF PERU

THIS AGREEMENT made this 20th day of November, 2023, by and between the City of Peru, an Illinois home rule municipal corporation (hereinafter, "City") and Total Environmental Service Technologies, Inc., an Illinois corporation (hereinafter, "Contractor").

WITNESSETH:

WHEREAS, the City owns two (2) Wastewater Treatment Facilities including appurtenances thereto (hereinafter, collectively, "Wastewater Plants") and Water Treatments Facilities, including water supply wells, two water softening plants, storage tanks, and booster stations (hereinafter, collectively, "Water Plants"); and

WHEREAS, the Wastewater Plants treat influent on a complex treatment basis consisting of a biological activated sludge process for removal of organic material with treated effluent discharging to the Illinois River and the waste sludge (treated by aerobic digestion and gravity thickening) for ultimate disposal by the City; and

WHEREAS, at the present time, the effluent of the Wastewater Plants under applicable State of Illinois rules and regulations, is not to exceed the average limits as listed on NPDES permit numbers IL0030600 and IL0075507 that are in effect with daily and other periodic samplings and testing of the effluent being required under the Wastewater Plants NPDES permits IL0030660 and IL0075507; and

WHEREAS, the Illinois Environmental Protection Agency (hereinafter, "IEPA") has classified the Wastewater Plants as a Group 1 facility, which requires the City to have a Class 1 certified operator in charge of the supervision and management of the Wastewater Plants operation, and, additionally, IEPA requires monthly confirmation reports by and on behalf of the City as to the Wastewater Plants' samplings and testings as called for under the NPDES permit; and

WHEREAS, the Water Plants treat water on a complex basis consisting of removal of iron and calcium/magnesium hardness and the addition of chlorine; and

WHEREAS, the IEPA has classified the Water Plants as a Class B facility which requires the City to have a Class B certified operator in charge of the supervision and management of the Water Plants Operation; and, additionally, the IEPA requires collection and submission of water samples and requires monthly reports to be submitted by the City concerning said sampling and testing; and

WHEREAS, Contractor represents and warrants that it has the technical facilities and operating personnel necessary for the proper and efficient operation of the Wastewater Plants and Water Plants as necessary and required for the efficient operation of the same pursuant to United States Environmental Protection Agency (hereinafter, "U.S. EPA") and IEPA requirements; and

WHEREAS, the City and Contractor desire to contract for the operation and maintenance of the Wastewater Plants and Water Plants under which Contractor shall undertake to furnish and provide the technical services, testings and reports for the Wastewater Plants and Water Plants operations at the times, in the manner, and to the extent as required by the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction, for the compensation as herein provided.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND AGREEMENTS HEREIN CONTAINED, THE PARTIES HERETO AGREE AS FOLLOWS:

ARTICLE I SERVICES TO BE PERFORMED BY OR AT THE EXPENSE OF CONTRACTOR

All of the following services provided in this Article I shall be provided by Contractor at its sole cost and expense:

- 1.1 Operation of Wastewater Plants. Within the design capacity and capability of the Wastewater Plants, Contractor shall manage, operate, and maintain the Wastewater Plants so that the effluent discharges from the Wastewater Plants meet or exceed the effluent requirements established by the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction.
- 1.2 Operation of Water Plant. Within the design capacity and capability of the Water Plants, Contractor shall manage, operate, and maintain the Water Plants so that the water distributed from the Water Plant meets or exceeds the quality standards established by the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction.
- **1.3** Operation of Splash Pad. Within the design capabilities of the Splash Pad, Contractor shall maintain the Splash Pad so that the water distributed from the Splash Pad meets or exceeds the quality standards of the IDPH and any other regulatory agencies having jurisdiction.
- 1.4 <u>Administration of Pretreatment Program.</u> Contractor shall administer the Pretreatment Program of the City pursuant to the Pretreatment Ordinance of the City and the requirements of the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction, including, but not limited to, preparation and receipt of applications, providing of technical assistance to industries within the City in the completion of the applications, the making of recommendations to industries with respect to the Pretreatment Ordinance, the reporting of Pretreatment Ordinance compliance as required by the Ordinance, U.S. EPA, IEPA, and City Council of the City, and the enforcement, with the assistance of the City Attorney, of the Pretreatment Program.
- 1.5 <u>Laboratory Analyses</u>. Contractor shall perform all routine laboratory analyses required by the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction concerning the Wastewater Plants and Water Plants and such other routine analyses as may be required in connection with the normal and efficient operation of the Wastewater Plants and Water Plants including, but not limited to, IEPA discharge monitoring report tests including influent testing, effluent testing, and special condition testing as required by NPDES permit IL 0030660, sludge permit, and water analyses as required by Division of Public Water Supplies of IEPA.
- 1.6 Reports and Budget to City Council. Contractor shall prepare and submit to the City monthly operating reports for the Wastewater Plants and Water Plants in such nature and detail as reasonably required by the City. Contractor shall assist in the preparation by the City of the operating budget for the Wastewater Plants and the Water Plants. Contractor shall attend all Water and Sewer Committee meetings, all regular City Council meetings, and such other meetings as requested by the City.
- **1.7** Monitoring Reports. Contractor shall prepare and timely submit all monitoring reports required to be submitted under the provisions of the rules and regulations of the U.S. EPA, IEPA, and/or any other regulatory agencies having jurisdiction over the Wastewater Plants and Water Plant.

- **1.8** <u>Preventive Maintenance</u>. Contractor shall establish and provide a reasonable preventive maintenance program for the equipment at the Wastewater Plants and Water Plants with the City to be responsible for all repair, modification and replacements costs and expenses; provided, however, the routine maintenance labor shall be furnished by Contractor.
- **1.9** Ordering. In accordance with the City's established procedures, Contractor shall order such supplies, repairs, replacements, parts, equipment and related items as are reasonably necessary for the mechanical operation of the Wastewater Plants and Water Plant.
- 1.10 <u>Personnel Requirements</u>. Contractor shall provide a qualified and minimum staff of six (6) full-time persons, plus support staff to manage, operate, and maintain the Wastewater Plants and Water Plants on a seven (7) day per week basis including the providing of regular and routine maintenance.

At least one of the designated qualified staff shall be a Class 1 Wastewater Treatment Plant Operator as designated by the IEPA and at least one of the designated qualified staff shall be a Class B Water Treatment Plant Operator as designated by the IEPA. The Class 1 Wastewater Treatment Plant Operator and the Class B Water Treatment Plant Operator shall have a minimum of five years' experience with the City's respective types of treatment operations.

At least two of the operations personnel shall possess a minimum Class 4 Wastewater and/or Class D Water certification. The Class 1 Wastewater Treatment Plant Operator and the Class B Water Treatment Plant Operator plus at least two of the other operations qualified minimum staff shall live within a ten-mile radius of the City.

Contractor shall provide a 24 hour emergency on-call service with the Class 1 Wastewater Treatment Plant Operator and the Class B Water Treatment Plant Operator and at least one other of the operations qualified minimum staff shall be on call.

Contractor shall provide coverage of the Wastewater Plants and the Water Plants every day of the year with a minimum weekend and holiday coverage of four hours per day. Contractor shall provide a company office telephone which shall be manned a minimum of forty hours per week during normal business hours to receive income telephone calls.

- **1.11** <u>Vehicles</u>. Contractor shall provide all vehicles necessary for its personnel in the management, operation, and maintenance of the Wastewater Plants and the Water Plants.
- **1.12** <u>Technical Interpretation</u>. Contractor shall provide technical interpretation assistance and make recommendations to the City concerning the compliance requirements of all applicable rules and regulations of all governmental agencies having jurisdiction over the operation of the Wastewater Plants and Water Plants including, but not limited to, the U.S. EPA, IEPA, and any other regulatory agencies having jurisdiction.

ARTICLE II CITY OBLIGATIONS

2.1 Equipment and Supplies. City shall provide all reasonably necessary equipment and supplies, replacement parts, and other related equipment necessary for the mechanical operation of the Wastewater Plants and the Water Plants. Contractor shall evaluate and make recommendations concerning these items, but the decision on purchase shall be within the sole discretion of the City.

- **2.2** <u>Utilities</u>. City shall provide all necessary utilities including, but not limited to, electrical power, fuel oil, water, refuse collection, and telephone services necessary for the mechanical operation of the Wastewater Plants and Water Plants.
- **2.3** <u>Sludge Disposal</u>. City shall provide sludge disposal sites acceptable to the governmental agencies having jurisdiction over the Wastewater Plants and Water Plants and shall provide for the transfer of the waste sludge from the Wastewater Plants and Water Plants to the respective disposal sites, including all transportation and disposal costs.
- **2.4** Snow Plowing and Equipment for Grass Cutting. City shall provide all necessary snow plowing and snow removal at the Wastewater Plants and Water Plants and shall provide the equipment necessary for the grass cutting.
- **2.5** <u>Capital Improvements</u>. City shall provide the necessary skilled craftsman or labor required, in addition to Contractor's staff, to perform any major capital repairs, replacements, or additions with such decisions to be within the sole discretion of the City.

ARTICLE III EPA FINES OR PENALTIES

3.1 <u>Contractor Obligation</u>. Contractor shall be responsible and liability for any penalties or fines that maybe imposed by the U.S. EPA, IEPA, or any other regulatory agency having jurisdiction of the Wastewater Plants and Water Plants for any discharge violations that may result due to the negligent, improper, inadequate, misfeasance, or nonfeasance of Contractor concerning the management, operation, or maintenance of the Wastewater Plants and/or Water Plants.

ARTICLE IV CONTRACTOR STATUS IS THAT OF INDEPENDENT CONTRACTOR

4.1 <u>Independent Contractor</u>. All work, services, and other functions furnished or to be performed by Contractor for the City under this Agreement shall be in Contractor's position as an independent contractor and to no extent and in no manner shall either Contractor, or any of its personnel who furnish the services, testings and reports to be provided by Contractor under this Agreement, be regarded as an employee, servant or agent of the City. It is understood that Contractor shall be responsible for all the services to be furnished or performed by employees or independent contractors of Contractor. Contractor shall be solely responsible for due compliance with all applicable Worker's Compensation, Scaffolding Act, Unemployment Insurance requirements, and all applicable payroll tax withholding and reporting requirements for each of its employees, and, if liable, any employees of independent contractors employed by Contractor.

ARTICLE V TERM OF AGREEMENT

5.1 Term. The Term of this Agreement shall commence on January 1, 2024, and shall end on December 31, 2028. In the event that the U.S. EPA, IEPA, or any other regulatory agency having jurisdiction of the Wastewater Plants and/or Water Plant disapproves of this Agreement at any time, then, anything herein to the contrary notwithstanding, this Agreement shall thereupon automatically terminate and become null and void within the sole discretion of the City.

ARTICLE VI CITY RIGHT OF TERMINATION

6.1 <u>City Right to Terminate</u>. The City, upon reasonable cause determined within the City's sole discretion, may upon thirty (30) days written notice to Contractor terminate this Agreement. In the event of City's exercise of this right to terminate this Agreement upon reasonable cause within the City's sole discretion, Contractor shall continue to perform all its duties and obligation under the terms of this Agreement until the date of termination, and, upon the date of termination, Contractor shall immediately vacate all premises of the City leaving the premises in a good and clean condition and repair.

In the event of City's election to terminate this Agreement, Contractor shall have no claim for damages of any nature whatsoever and Contractor hereby waives any remedy (legal, equitable, or otherwise) against the City except for any accrued compensation due under this Agreement until the date of termination.

ARTICLE VII CONTRACTOR INSURANCE AND LIABILITY LIMITS

7.1 Contractor Insurance. Throughout the term of this Agreement, Contractor shall maintain at its sole cost and expense, public liability insurance for bodily injury and property damage covering all personnel, automobiles, and other equipment employed, owned, or used by Contractor in performing its duties under the terms of this Agreement. Each liability policy shall have limits of not less than \$1,000,000.00 in the aggregate and the City shall be a named insured on all such policies.

ARTICLE VIII COMPENSATION

- **8.1** Compensation. As full consideration and compensation for the duties and obligations of Contractor under this Agreement, the City shall pay to Contractor the sum of \$615,721.86 for each year for the term of this Agreement, with payment thereof to be made in twenty-six (26) bi-weekly installments of \$23,681.61 per year.
- 8.2 Extraordinary Compensation. In the event of extraordinary equipment breakdown or acts of God not due to Contractors fault or regular and routine maintenance problems, the City shall pay Contractor additional compensation for extraordinary overtime incurred by Contractor in excess of ten (10) extraordinary man hours per month caused by such extraordinary equipment breakdown or acts of God not due to Contractor fault or regular routine maintenance problems, provided, however, before Contractor incurs any expenses under the provisions of this paragraph, such expenses shall be so authorized by the City. The rate of additional compensation shall be at Contractor's cost (salary of employee plus salary overhead which shall include Social Security taxes, Federal Unemployment Taxes, Illinois Unemployment Taxes, Worker's Compensation, health, welfare, and pension) and due within thirty (30) days upon receipt of a documented invoice.

ARTICLE IX NOTICES

9.1 Notices. All notices required or permitted to be given or delivered hereinunder shall be given by certified mail, return receipt requested, postage prepaid, and when so mailed shall be deemed to have been given on the day deposited in the United States mails, addressed to the party to be notified at the address listed below, or, in case the party to which such notice is directed has previously notified the party given such notice of a change in mailing address, to such changed address:

ARTICLE X MISCELLANEOUS

- **10.1** <u>IEPA Approval</u>. This Agreement, and any payments hereunder, are expressly contingent upon approval by the IEPA pursuant to Subpart I, Section 380.901, 380.902, and 380.903, Procedures for the Certification of Wastewater Treatment Works.
- **10.2 No Assignment**. This Agreement shall not be assigned by Contractor without the express written consent of the City, which consent City may, in its sole discretion and without reason, refuse.
- 10.3 Additions or Improvements. The terms Wastewater Plants and Water Plants as used in this Agreement shall include all present facilities used for such respective purposes plus any additional facilities which may be constructed during the term of this Agreement for any such purposes and specifically include, but not by way of limitation, the improvements to the Wastewater Plants to be constructed pursuant to the approved IEPA Municipal Compliance Plan of the City.
- 10.4 <u>Subsequent Regulatory Changes.</u> Contractor, pursuant to the terms of this Agreement, shall implement and comply with all rules and regulations of the U.S. EPA, IEPA, or any other governmental agency having jurisdiction over the Wastewater Plants and/or Water Plants whether presently existing or hereinafter amended or enacted.
- 10.5 <u>Contractor Transfer or Sale of Assets</u>. In the event Contractor sells, transfers, or assigns more than fifty percent (50%) of its assets or there is a transfer of ownership of more than fifty percent

(50%) of the corporate stock of Contractor, the City, within its sole discretion, may elect to immediately terminate this Agreement upon giving either oral or written notice to Contractor and, in the event of such termination, Contractor shall have no claim for damages or remedy (legal, equitable, or otherwise) against the City, except for any accrued compensation due under this Agreement until such date of termination.

- 10.6 <u>Attorney's Fees</u>. In the event Contractor breaches any of the covenants herein or obligations or duties to be performed upon Contractor's part and such breach results in any litigation between the parties, City shall be allowed all reasonable costs and attorney's fees expended or incurred in any such litigation to be recovered as part of the cost therein.
- **10.7 Invalidity**. If any portion or provision of this Agreement shall be declared invalid or unenforceable, such invalidity or unenforceability shall not affect the remainder of this Agreement which shall remain in full force and effect.
- 10.8 <u>Construction and Forum</u>. This Agreement shall be construed and enforced in accordance with the laws of the State of Illinois and any dispute concerning this Agreement, if not otherwise amicably resolved, shall be resolved in the Circuit Court of LaSalle County, Illinois, which Circuit Court shall be the only forum for adjudication of disputes under this Agreement.

ORDINANCE NO. _____AN ORDINANCE ANNEXING AND ZONING CERTAIN TERRITORY TO THE CITY OF PERU, ILLINOIS (8.26± acres)

WHEREAS, after a public hearing as required by law, the City Planning/Zoning Commission unanimously recommended that the City Council annex and zone the Territory R-2 Single-Family Residence District; and

WHEREAS, the City Council finds and determines that it is in the best interest of the City for the Territory to be annexed to the City and zoned R-2 Single-Family Residence District.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PERU, ILLINOIS, A HOME RULE MUNICIPALITY, AS FOLLOWS:

SECTION 1: Recitals. The City Council finds as fact the recitals contained in the preamble to this Ordinance, and hereby incorporates them herein by reference.

SECTION 2: Annexation. The Territory, being described and depicted on the Annexation Plat attached hereto and incorporated herein, is hereby annexed to the City of Peru, Illinois.



SECTION 2: Provided that Illinois Valley Auto Group demonstrates its intent to commence and complete the redevelopment of the Subject Property in accordance with plans to be filed with and approved by the City, and further in accordance with all applicable City codes, ordinances, and permits; the City shall vacate, pursuant to 65 ILCS 5/11-91-1 and the terms of this Ordinance, that portion of Frontage Road which is described and depicted on the attached Vacation Plat to Illinois Valley Leasing Co. d/b/a Illinois Valley Auto Group upon receipt of and 00/100 Dollars (\$_______) therefrom.

SECTION 3: The vacation of that portion of Frontage Road described and depicted on the attached Vacation Plat (hereinafter, the "Vacated Area") shall be subject to the following:

- (a) The City hereby reserves for itself and for all public utility companies presently operating in, upon, over and under said Vacated Area, all rights and privileges heretofore granted to said City and companies with respect to said Vacated Area, including but not limited to all rights under any franchises and agreements, which rights and privileges shall continue in full force and effect as if this Ordinance had not been adopted or passed.
- (b) The City, for itself and its successors, permittees and assigns, hereby reserves the following perpetual rights and easements in, over, across, under, along, and upon the Vacated Area:

- (1) to construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time-to-time sanitary sewers and storm sewers and any and all manholes, tiles, pipes, connections, catch basins, and, without limitation, such other installations as may be required or may be deemed necessary by the City for sanitary and/or storm sewer purposes;
- (2) to construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time-to-time water mains and lines and any and all necessary manholes, tiles, pipes, connections, catch basins, fire hydrants, buffalo boxes, and, without limitation, such other installations as may be required or may be deemed necessary by the City for water service purposes;
- (3) to construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time to time, electric transmission, distribution, communication lines and systems, and, without limitation, such other installations as may be required or may be deemed necessary by the City for electric and communication service purposes; and
- (4) to establish, without payment of any compensation whatsoever, an exclusive easement area of up to two hundred (200) square feet anywhere upon the Vacated Area for purposes of erecting, placing, operating, and maintaining an unobstructed sign structure(s) at the City's sole cost and expense, the location of which area and sign message content shall be in the sole discretion and control of the City.





Section 6. Default, Possession, Landlord's Lien, Right of Entry, Mineral Rights, Liability, Extent of Agreement

The Lessor and Tenant agree to the following provisions. (Strike out any not desired.)

- **A. Termination upon default.** If either party fails to carry out substantially the terms of this lease in due and proper time, the lease may be terminated by the other party by serving a written notice citing the instance(s) of default and specifying a termination date of 30 days from the date of such notice. Settlement shall then be made in accordance with the provisions of Clause B of this section, the reimbursement agreements of Section 5, and any amendments to this lease.
- **B. Yielding possession.** The Tenant agrees at the expiration or termination of this lease to yield possession of the premises to the Lessor without further demand or notice, in as good order and condition as when they were entered upon by the Tenant, loss by fire, flood, or tornado, and ordinary wear excepted. If the Tenant fails to yield possession, the Tenant shall pay to the Lessor a penalty of \$150 per day or the statutory double rent, whichever is less, for each day the Tenant remains in possession thereafter, in addition to any damages caused by the Tenant to the Lessor's land or improvements, and said payments shall not entitle the Tenant to any interest of any kind or character in or on the premises.
- C. Landlord's lien. The Landlord's lien provided by statute on crops grown or growing, together with any other security agreement(s) created by Tenant in favor of Landlord, shall be the security for the rent herein specified and for the faithful performance of the terms of the lease. The Tenant shall provide the Lessor with the names of persons to whom the Tenant intends to sell crops grown on these premises at least 30 days prior to the sale of such crops. A lesser period may be allowed by mutual written agreement. Tenant consents to any filing required by law to perfect the statutory landlord's lien upon crops. If the Tenant fails to pay the rent due or fails to keep any of the agreements of this lease, all costs and attorney fees of the Lessor in enforcing collection or performance shall be added to and become a part of the obligations payable by the Tenant.

- D. Landowner's right of entry. The Lessor reserves the right personally or by agents, employees, or assigns to enter upon the premises at any reasonable time to view them, to work or make repairs or improvements thereon, to care for and dispose of the Lessor's share of crops, to develop mineral resources as provided in Clause E below, or, after constructive notice has been given that the lease may not be extended, and following severance of crops, to plow and prepare a seed bed, apply fertilizers, and any other operation necessary to good farming by the succeeding operator, these operations not to interfere with the Tenant in carrying out the regular farming operations.
- E. Mineral rights. Nothing in this lease shall confer upon the Tenant any right to minerals underlying the land. Such mineral rights are hereby reserved by the Lessor together with the full right to enter upon the premises and to bore, search, excavate, work, and remove the minerals, to deposit excavated rubbish, to pass over the premises with vehicles, and to lay down and work any railroad track or tracks, tank, pipelines, power lines, and structures as may be necessary or convenient for the above purpose. The Lessor agrees to reimburse the Tenant for any actual damage the Tenant may suffer for crops destroyed by these activities and to release the Tenant from obligation to continue farming this property when development of mineral resources interferes materially with the Tenant's opportunity to make a satisfactory return.
- **F. Landowner liability.** The Tenant takes possession of the leased premises subject to the hazards of operating a farm, and assumes all risk of accidents personally as well as for family, employees, or agents in pursuance of farming operations, or in performing repairs on buildings, fences, tile, and other improvements.
- **G. Binding on heirs, etc.** The terms of this lease shall be binding on the heirs, executors, administrators, and assigns of both Lessor and Tenant in like manner as upon the original parties.

Section 7. Additional Lease Provisions

Early Termination.

Lessor may terminate this Lease as to all or any part of the premises at any time upon thirty (30) days written notice to Tenant and Tenant shall relinquish and release possession to Landlord of all or such portion of the premises as specified in the written notice. If, on the effective date of the notice of termination as provided herein, Tenant's crops are not ready for harvest, Landlord shall reimburse Tenant the cash rent paid hereunder (or prorated part, if applicable) and shall further reimburse Tenant for Tenant's costs actually incurred during the term of this Lease for seed, fertilizer, herbicide, insecticide and fuel used for such crops.

- (a) To construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time to time water mains and lines, sanitary sewers, storm sewers and any and all manholes, tiles, pipes, connections, catch basins, fire hydrants, buffalo boxes and, without limitation, such other installations as may be required or may be deemed necessary by Grantee for water, sanitary and/or storm sewer purposes;
- (b) To construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time to time water mains and lines and any and all necessary manholes, tiles, pipes, connections, catch basins, fire hydrants, buffalo boxes, and, without limitation, such other installations as may be required or may be deemed necessary by Grantee for water service purposes; and
- (c) To construct, operate, repair, maintain, patrol, inspect, relocate, reconstruct, and remove from time to time, electric transmission, distribution, communication lines and systems, and, without limitation, such other installations as may be required or may be deemed necessary by Grantee for electric and communication service purposes;

in, over, under, across, along, and upon the real estate described and depicted on the Easement Plat attached hereto and incorporated herein (hereinafter, "Easement Tract").

The aforesaid perpetual rights and easements are granted together with the right (i) to use adjacent roads, streets, and alleys for such purposes and to use reasonable working space adjacent to said Easement Tract during construction or maintenance of said utility systems; (ii) to control the growth of any vegetation, trees, shrubs, or saplings on the Easement Tract; and (iii) to clear and remove, without any liability whatsoever to Grantee, any obstacles on the Easement Tract


