**CITY OF PERU REGULAR COUNCIL MEETING APRIL 7, 2025**

A regular meeting of the Peru City Council was called to order by Mayor Ken Kolowski in the Peru City Council Chambers on Monday, April 7, 2025, at 7:02 P.M.

City Clerk Dave Bartley called the roll with Aldermen Ballard, Tieman, Payton, Edgcomb, Sapienza, O’Sadnick, Lukosus and Moreno present. Mayor Kolowski present.

Mayor Kolowski presented the Regular Minutes of March 24, 2025, Building Permit Report- 1<sup>st</sup> Quarter 2025, and Peru Police Department Monthly Report for March 2025. Alderman Payton made a motion the minutes be received and placed on file. Alderman Sapienza seconded the motion; motion carried.
